The East Riding of Yorkshire Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) as amended and in pursuance of powers granted by the Secretary of State under Section 74 and Part 2 of Schedule 8 and under Paragraph 8 of the Traffic Management Act 2004 (hereinafter referred to as “the Act of 2004”) as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the 3rd day of January 2019 and may be cited as The East Riding of Yorkshire Council(On Street Parking Places(Civil Enforcement)(Consolidation)(Amendment No.24)) (Treeton Road, Howden) Order 2018.
2. The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2014 is hereby amended to the following extent:
 - (a) The Plan Tile Reference EV46 specified in Schedule 1 (Parkmap Schedule 24.01) to this Order is hereby revoked and:
 - (b) The Plan Tile Reference EV46A specified in Schedule 2 (Parkmap Schedule 25.01) to this Order is hereby inserted.
