



- 1. On the 16 March 2018 The East Riding of Yorkshire Council made this Order which will be operative from the 16 March 2018 and will amend The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 the effect of which will be:-
 - (a) To extend the Beverley Controlled Parking Zone (CPZ) to include Keldgate Bar and Kitchen Lane (residents parking permits available to residents at a cost of £30.00 per annum for one vehicle and £105.00 per annum for a second vehicle, visitor permits available at a cost of £10.00 for a book of ten scratch card, bona fide contractors permits at a cost of £10.00 for one day, £20 for one week, £35 for 1 month or £105.00 per annum, carers permits at a cost of £30.00 per annum).
 - (b) To make Keldgate Bar into a Mews Parking Area which means a parking area within a Controlled Parking Zone which can only used by vehicles which display a valid CPZ permit. Mews parking areas do not require marked bays or provide a one hour limited waiting period for non-permit holders (Signed "For residents only" on entering the culde-sac).
 - (c) To introduce a No Waiting at Any Time restriction on both sides of the entrance to Keldgate Bar, Beverley
- 2. A copy of the Order and relevant plans may be examined during normal office hours at the Beverley Customer Service Centre, Cross Street, Beverley, HU17 9BA. (Ref MG/76958)
- 3. If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the 16 March 2018 apply to the High Court for this purpose.
