ORDER 2017

The East Riding of Yorkshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) as amended and in pursuance of powers granted by the Secretary of State under Section 74 and Part 2 of Schedule 8 and under Paragraph 8 of Schedule 9 of the Traffic Management Act 2004, and of all other enabling powers, and after consultation with the Chief Constable of Humberside Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

**SECTION 1 – PRELIMINARY**

Citation and commencement

1. This Order shall come into operation on the 21st day of December 2017 and may be cited as The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017.
2. The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2017 Plans including the key (“the Plans”) are incorporated into this Order.

Interpretation

3. In this Order, except where the context otherwise requires, the following expressions have the meaning hereby respectively assigned to them:

“Council” means The East Riding of Yorkshire Council and includes any parking services contractors or authorised agent appointed by or acting on behalf of the Council for the purposes of any function under the provisions of this Order;

"1984 Act" means the Road Traffic Regulation Act 1984

"2004 Act" means the Traffic Management Act 2004

“2016 Regulations” means the Traffic Signs Regulations and General Directions 2016

“administration fee” means a non-refundable charge levied by the Council for undertaking the administration work associated with parking permits, vouchers, parking waivers, suspensions and dispensations including hard copy and virtual versions;

“ambulance” means a motor vehicle which is constructed or adapted, and primarily used for carriage of person to a place where they will receive, or from a place they have received, medical treatment and which by reason of design, marking, livery or equipment is readily identifiable as an emergency vehicle

“alternative approved method of payment” means cashless payments, park and phone, payment by debit or credit card facilitated by on site or remote verification by, for example, card reader or mobile phone text or phone call or decrementing card;

“article” means an article of this Order unless otherwise stated and includes reference to any paragraph of that Article referred to by number or letter;

“authorised agent” means a third party being a company or individual with written authorisation to act on behalf of the council;

“bank holiday” has the same meaning as described in the ‘Banking and Financial dealings Act 1971 (C.80).

“card” means either a “credit card” or a “debit card” where “credit Card” and “debit Card” have the same meanings as given by Section 35A (6) of the 1984 Act and an “approved card” shall be one which is listed on the Council’s web site and/or parking place information board as a card approved for the purposes of payment for parking charges;

“carer” means anyone, as determined from time to time by the Council, who performs a caring function in the community and can include registered carers, doctors, district nurses, professional carers and other qualified medical practitioners who have a genuine reason to park in residents permit or time limited parking places while visiting a resident in a caring situation;

“carer permit” means a permit issued at the absolute discretion of the Council to a person who or organisation which is construed as a carer;

“carer’s permit holder” means a person to whom at the absolute discretion of the Council a carer’s permit has been issued in accordance with the provisions of this Order;

“certificate of residence” means specific documentary evidence and or any other supportive information that the Council may require such as it considers appropriate to confirm that a person is a resident of a controlled parking zone or road or street named in Schedule 3;

“charging days” means days, including Bank Holidays, as specified in Schedule 2 and by notice at each parking place respectively;

“charging hours” means the period as specified in Schedule 2 and by notice at each parking place respectively;

“civil enforcement officer” means a person employed by, or on behalf of, the Council under Part 6 of the 2004 Act and in accordance with Section 76 of the 2004 Act authorised to supervise and enforce the restrictions imposed by this Order and to carry out the functions therein;

“clearway” means the main carriageway of any of the sides or lengths of roads specified in the plans where stopping is prohibited during the restricted hours provided that the expression clearway shall not include any lay-by or parking place;

“community care personnel” means persons who are employed by or who are members of an official carers organisation operating through the Council or the National Health Service;

“controlled parking zone” or “CPZ” means an area specified on the plans within which parking permits may be authorised for use in the roads or streets within that area.

“delivering” or “delivery” or “collection” means the transfer of goods to or from a stationary vehicle, to or from a place adjacent to or in close proximity to the location of that stationary vehicle, including postal packets of any description, and reasonable time for checking the goods for the purpose of their delivery or collection;

“disabled person’s badge” has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000, a badge coloured blue in accordance with the Department for Transport Blue Badge scheme;

“disabled person’s parking disc” has the same meaning as in the Local Authorities’ Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000; means a disc, issued by a Local Authority, 125 millimetres square, coloured blue and capable of showing the quarter hour period during which a period of waiting or parking begins;

“discretionary permit” means a permit issued at the absolute discretion of the Council to a person who or organisation that can demonstrate and provide sufficient evidence to satisfy the Council that their circumstances constitute a special case for the issuing of a permit;

“dispensation certificate” means a certificate issued on or behalf of the Council under the provisions of this Order permitting a specified vehicle to park or wait in specified circumstances in a parking place, where the parking or waiting of that vehicle would otherwise be restricted or prohibited;

“doctor” means a medical professional as defined in the Medical Act 1983,

“district nurse” means a medical professional who performs a caring function in the community registered with the Nursing & Midwifery Council,

“driver” in relation to a vehicle left, waiting or parked in a restricted area or parking place respectively, means the person driving the vehicle at the time it was left, waiting or parked in the prohibited or restricted parking area or parking place or the person deemed to be the driver under the terms of this Order;

“east riding wide daily ticket” means a ticket issued by a pay and display ticket machine to permit parking between the hours of 8am to 6pm in any long stay parking place on the day of purchase (except South Cliff Park and Ride Site, Bridlington) which are subject to parking charges on the day of purchase;

“enactment” means any enactment, whether public, general or local, and includes any order, byelaw rule, regulation, scheme or other instrument having effect by virtue of an enactment;

“event times” means periods on any specific day when special events are taking place which require regular but temporary prohibition or restriction of waiting or loading or parking. At event times, appropriate signs to the 2016 Regulations will be in place to indicate any specific required restrictions;

“expiry time” is the time indicated on the pay and display ticket and is the time by which the vehicle must leave the parking place;

“free 30 minute parking period ticket” means a ticket issued by a pay and display ticket machine to permit free parking for the first period of parking as specified in the “hourly Charge” column of Schedule 2 of this Order;

“goods” and “merchandise” means goods of any kind whether animate or inanimate and includes postal packets of any kind;

“goods vehicle” means a motor vehicle which is constructed or permanently adapted for the carriage of goods or merchandise or burden of any description or a trailer so constructed or permanently adapted for the carriage of goods or merchandise or burden of any description provided that a trailer (including for this purpose when the trailer forms part of an articulated vehicle) shall not be deemed to be a goods vehicle for the purpose of this Order unless it is attached at all times to the vehicle towing it;

“hackney carriage” means a vehicle licensed under Section 37 of the Town Police Clauses Act 1847;

“hotel” or “guest house” means any property used for the purpose of a business of letting rooms to individuals upon payment and with or without a meal;

“hourly charge” means the charge imposed by the Council for parking in a parking place on any one day and for a specified period of time as is identified in the scale of charges specified in Schedule 2 or as may be varied in accordance with Section 35C of the Act of 1984 and by notice at each parking place respectively;

“household” means a house or flat which has its own postal address. In the case of sub-divided properties the establishment of an individual address is subject to any appropriate planning consent having been obtained for the sub-division of the property and the paying of separate Council Tax;

“key” means the key attached to the Plans to be read in conjunction with the Plans;

“lay-by” in relation to a main carriageway means any area of a highway at the side of the main carriageway but not part of it and marked in accordance with the the 2016 Regulations intended for the parking or waiting of vehicles, provided that no person shall cause or permit any vehicle to park or wait in any lay-by for the purpose of selling goods or services from that vehicle except where displaying a certificate of Street Trading Consent issued by the Council and the vehicle is being operated in accordance with any conditions of the said certificate;

“loading” and “unloading” means a vehicle parked or waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises or adjacent to premises or nearby premises provided that the vehicle does not park or wait for such longer period as required to complete the task or for such period as duly authorised by a police officer in uniform, civil enforcement officer or a person authorised by the Council. Loading and unloading is a continuous activity and if no signs of this activity are observed over a five minute period it will be deemed that this activity is not taking place;

“loading area” means any of the sides or lengths of roads specified on the Plans where activities other than loading are prohibited;

“licensed taxi” means in England and Wales, a vehicle licensed under Section 37 of the Town Police Clauses Act 1847;

“main carriageway” means that part of a public highway used primarily for through traffic provided that the expression main carriageway shall not include any lay-by;

“market day or days” means periods on any specific day or days when trading is undertaken on street from stalls or other approved and authorised placements;

“midwife” means a medical professional who performs a caring function in the community registered with the Nursing & Midwifery Council,

“motor caravan” means a motor vehicle which is constructed or adapted for the carriage of passengers and their effects and which contains as permanently installed equipment, the facilities which are reasonably necessary for enabling the vehicle to provide mobile living accommodation for its users;

“motor car” has the same meaning as that in S136 of the 1984 Act

“motor cycle” has the same meaning as that in S136 of the 1984 Act;

“motor cycle and sidecar” has the same meaning as that in S136 and 137 of the 1984 Act;

“motor tricycle” means a mechanically propelled vehicle with three wheels, a design speed greater than 50km per hour and an unladen weight of no more than 550kg, not being a motor cycle with three wheels;

“motor quadricycle” means a mechanically propelled vehicle with four wheels, a design speed greater than 50km per hour and an unladen weight of no more than 550kg;

“motor vehicle” has the same meaning as that in S136 of the 1984 Act;

“no loading hours” means in relation to any no loading road the hours during which loading and unloading is restricted as specified on the Plans;

“no loading road” means any of the sides or lengths of roads specified on the Plans where loading is prohibited provided that the expression “no loading road” shall not include any parking place;

“no stopping hours” means in relation to any no stopping road the hours during which stopping is restricted as specified on the Plans;

“no stopping road” means any of the sides or lengths of roads (including clearways) specified on the Plans where stopping is prohibited provided that the expression “no stopping road” shall not include any parking place;

“nurse” means a medical professional who performs a caring function in the community registered with the Royal College of Nursing and is professionally accountable to the Nursing and Midwifery Council;

“official funeral vehicle” means a vehicle specifically adapted for the transportation of corpses or a professionally driven vehicle that carries the livery of the operating Funeral Directors;

“official wedding vehicle” means a professionally driven vehicle used for the transportation of the person or persons being married, or the “best man” or the Bridesmaids;

“one-way street” means a highway in which the driving of vehicles except pedal cycles if so specified on the Plans otherwise than in one direction is prohibited;



“operating hours and days” means the times during which payment parking places are available for use with or without payment;

“owner” in relation to a vehicle, means the person by whom such vehicle is kept and used. In determining who was the owner on the date on which the vehicle was parked or waiting it shall be presumed that the owner is the person recorded as the registered keeper by the Driver and Vehicle Licensing Agency and or named in the vehicle registration document as the registered keeper of the vehicle or the person who is entitled to use such vehicle as though he / she were the registered keeper thereof;

“park” and “parked” refer to the stopping of a vehicle and it remaining at rest for some time whether or not the driver is still in the vehicle and a vehicle shall be deemed to be parked for any period in the same parking place or parking bay (as the case may be) if any part of it is below the vehicle or the vehicle’s load (if any) whether or not the vehicle is moved during that period;

“park and phone” means a method of payment of the parking charge involving registration of payment by phone or electronic means and, on first use, registration of the relevant registration number of the vehicle, location of the parking place, credit or debit card details or any such other details as the Council may from time to time require which is accepted by the Council as a valid method of payment for the relevant time of use of the parking place;

“parking bay” means an area of a parking place, which is provided for the leaving of a vehicle of a class specified and indicated by markings on the surface of the parking place or delineated by block paving or physical features or signed or otherwise indicated by signs in the parking place;

“parking device” has the meaning given by Sections 35(3)(b) and Section 51(4) of the 1984 Act;

“parking place” and “parking bay” means an area of a highway designated by this Order for the parking of vehicles of specific classes;

“passenger vehicle” means a motor vehicle (other than a motor-cycle or invalid carriage) constructed or adapted solely for the carriage of not more than twelve passengers (exclusive of the driver) and their effects and not drawing a trailer;

“pay and display ticket machine” means an apparatus of a type and design approved by the Secretary of State for the purpose of the 1984 Act, being apparatus designed to indicate the time by a clock and to issue a ticket indicating the payment of a charge, the date on which the issued ticket is valid and either the time of such payment or the expiry time of the parking period for which payment has been made;

“pay and display ticket” means a ticket issued by a pay and display ticket machine relevant to the parking place in which a vehicle has been parked;

“penalty charge” means a penalty charge relating to a parking contravention and payable in accordance with Regulation 4 of the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 or any subsequent legislation so enabling;

“penalty charge notice” has the meaning given by Regulation 8(1) of the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 or any subsequent legislation so enabling;

“permit” means any permit issued by the Council and bearing printed instructions for its validation on the front or back, designed to indicate a period of time when a vehicle may park within a specified parking place, street or pay and display bay in accordance with the provisions of this Order;

“permit holder” means a person to whom a permit has been issued under the provisions of this Order;

“permitted hours” means the periods specified for each parking place during which parking by vehicles of a specific class is permitted as specified on the Plans;

“Person authorised by the Council” means a member of the council’s Parking Operations Team;

“the plans” or “the Plans” means the digitally held plans which are held at the Offices of The East Riding of Yorkshire Council showing the parking controls referred to in this order, the reference numbers for which are listed in Schedule 1;

“police vehicle” means a vehicle used by a warranted police officer in exercise of their duties whether or not that vehicle displays any insignia or livery;

“postal packet” has the same meaning as in Section 87 of the Post Office Act 1953;

“prohibited hours” means in relation to any prohibited road the hours during which waiting or loading is prohibited as specified on the Plans;

“prohibited road” means any of the sides or lengths of roads specified on the Plans where waiting is prohibited provided that the expression “prohibited road” shall not include any parking place;

“public holiday” means Christmas Day, Good Friday and any other day designated by the Government as a public holiday;

“Public Service Vehicle” has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981, as amended by the Transport Act 1985;

“Public Telecommunications Operator” has the same meaning as in Section 9 of the Telecommunications Act 1984;

“qualified medical practitioner” means a fully registered person within the meaning of the Medical Act 1983;

“registered carer” means any person employed by the Council or the National Health Service to provide medical or clinical care regularly away from their usual place of work to individuals in their homes or to other people in the exercise of its functions under any enactment

“registration card” means a paper or electronically held card issued by the Council under the provisions of this Order to either a resident or the owner of a hotel or guest house in a controlled parking zone on payment of such fee as the Council may from time to time determine certifying that the holder is entitled to a permit;

“relevant position” in respect of: -

- a) A disabled person’s badge, or a disabled person’s parking disk, or a permit, or a pay and display ticket, or a scratch card, or a dispensation, or a waiver means; exhibited on the windscreen, dashboard or fascia of the vehicle with the obverse side facing forwards on the near side of and behind the windscreen or where the vehicle does not have a windscreen, dashboard or fascia, in a conspicuous position on the vehicle, and in both circumstances orientated so that the whole of the information on the front of the permit,

badge, disc, ticket, card, dispensation or waiver, is clearly legible from outside the vehicle.

Or

- b) A hackney carriage plate means the plate must be affixed to the vehicle in accordance with the instructions given within the licence as issued by the East Riding of Yorkshire Council or in the case of another Council in accordance with their instruction;

“resident” means a person whose principal residence is at premises the postal address of which is in any road or part of road in a controlled parking zone or any other road or part of road as specified in Schedule 3;

“restricted hours” means in relation to any restricted road the hours during which waiting is restricted or specific activities are restricted as specified on the Plans;

“Restricted Parking Zone (RPZ)” means an area where waiting and/or loading restrictions apply but where no road markings/lines are required to be provided on the carriageway. Motorists are advised of the restrictions within the RPZ using signage. The RPZ uses boundary/entry signs and intermittent repeater/reminder signs indicating the hours of restriction within the zone. Where no times and days of the week are stated on the boundary/entry signs, the restrictions apply at all times for all days of the week. When except in signed bays is stated on the boundary signs there will be provision for on street parking and/or loading within the zone, these locations will be indicated using contrasting paving/surface material or physical features to delineate the bays.

“restricted road” means any of the sides or lengths of roads specified on the Plans where waiting is restricted or specific activities are restricted during the restricted hours provided that the expression “restricted road” shall not include any parking place;

“school keep clear” means any area of carriageway of a road which is specified on the Plans and intended to be kept clear of stationary vehicles being in close proximity to a school pedestrian access and indicated by road markings complying with diagram 1027.1, Item 10 of the signs table, Part 4, Schedule 7 of the 2016 Regulations as indicated by Traffic Signs complying with Regulation 3, Part 6, Schedule 7 of the 2016 Regulations.;

“scratch card” means a permit issued by the Council and bearing printed instructions for its validation on the front or back, designed to indicate a period of time when a vehicle may park within a specified parking place, street or pay and display bay in accordance with the provisions of this order;

“second resident permit” means a second permit issued by the Council under the provisions of this Order;

“special enforcement area” the whole of the East Riding of Yorkshire is a special enforcement area by virtue of Statutory Instrument 2011 No.2431;

“statutory undertaker” has the same meaning as in Section 329 of the Highways Act 1980;

“security carrier” means a vehicle designed or adapted for or in use for the conveyance of bullion, monies and currency and other securities;

“suspension certificate” means a certificate issued by or on behalf of the council under the provisions of this Order suspending a parking place or places in specified circumstances;

“taxi rank” means an area of carriageway which is indicated by road markings complying with a diagram 1028.4, Item5 of the table of signs, Part 4, Schedule 7 of the 2016 Regulations, for use by hackney carriages and licensed taxis;

“telecommunication system” has the same meaning as in the Telecommunications Act 1984;

“ticket” or “parking ticket” means a ticket issued by a pay & display ticket machine relating to a parking place in which the vehicle has been parked and valid for a parking period as advertised at the parking place and on the ticket;

“traffic regulation order” or “TRO” have the same meaning respectively, that being an Order made under the Section 1 of the 1984 Act;

“Traffic Sign” means a sign or road marking of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under, the 2016 Regulations or approved for use by the Department for Transport;

"trailer" means a vehicle drawn by a motor vehicle;

“universal service provider” and “universal postal service” shall bear the same meanings as in the Postal Services Act 2000;

“virtual parking permit” means an electronic record of a parking permit, certificate, voucher, suspension, dispensation or waiver of any kind issued and confirmed by East Riding of Yorkshire Council to exempt a vehicle from a restriction under the terms and charges applicable at the time of issue;

“virtual parking ticket” means an electronic record of a parking ticket of any kind issued and confirmed by East Riding of Yorkshire Council to permit a vehicle to park in a pay and display bay under the terms and charges applicable at the time of issue;

“virtual registration card” means an electronic record made by the council under the provisions of this Order certifying the entitlement of a resident or the owner of a hotel or guest house in a controlled parking zone on payment of such fee as the council may from time to time determine to a specified permit or permits;

“visitor parking permit” means a permit or scratch card issued by the Council under the provisions of this Order on application by a resident to enable the parking of a vehicle belonging to a bona fide visitor to a resident to park in such a parking place designated for vehicles displaying a residents permit;

“wait” and “waiting” refer to the stopping of a vehicle and it remaining at rest for some time whether or not the driver is still in the vehicle other than for the purposes of delivering, delivery or collection of goods; and a vehicle shall be deemed to be waiting for any period in the same prohibited or restricted road, parking place or parking bay (as the case may be) if any part of it is below the vehicle or the vehicle’s load (if any) whether or not the vehicle is moved during that period;

“waiver certificate” means a certificate issued by or on behalf of the Council for the purposes of this Order permitting a specified vehicle to wait in specified circumstances on a length or lengths of road where the waiting of that vehicle would otherwise be restricted or prohibited.

4. Any reference in this Order to a numbered Article shall, unless the context requires otherwise, be construed as a reference to the Article bearing that number in this

Order and any reference to the Plans is a reference to the Plans incorporated into this Order.

5. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
6. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if for the purposes of Section 21 of that Act this Order were an Act of Parliament and the Orders revoked by this Order were Acts of Parliament thereby repealed.
7. Unless the context otherwise requires, words denoting the singular shall include the plural and vice versa and words denoting the persons shall include either gender, bodies corporate, unincorporated associations and partnerships.
8. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment.
9. If a court, the Department for Transport, the Traffic Penalty Tribunal or the Traffic Enforcement Centre declares any part of this Order to be invalid or un-enforceable, such declaration shall not invalidate the remainder of the Order.

## **SECTION 2 – PROHIBITION AND RESTRICTION OF WAITING AND LOADING**

### **Prohibition of waiting and parking**

10. Save as provided in Articles 19, 21 to 31 no person shall cause or permit any vehicle to wait or park at any time on any prohibited road as specified on the Plans.

### **Restriction of waiting and parking**

11. Save as provided in Articles 19, 21 to 31 no person shall cause or permit any vehicle or a vehicle of a specific class to wait or park on any restricted road during the restricted hours as specified on the Plans.



#### Special Event only prohibitions and restrictions

12. Save as provided in Article 18 no person shall cause or permit any vehicle to wait or park in any prohibited or restricted road at event times as indicated on the Plans when they are displayed on the prohibited or restricted road signs as prescribed by the 2016 Regulations or signs specially authorised by the Department of Transport indicating prohibition or restriction of parking.
13. At event times, the provisions for the normal prohibitions and restrictions of parking as indicated on the Plans on roads affected by the event time restrictions are suspended for the duration of the period expressed on the signs placed under Article 12 or until such time those signs are removed from the prohibited or restricted road.

#### Loading areas

14. Save as provided in Articles 20 and 21 no person shall cause or permit any vehicle to wait or park during the restricted hours in any loading area specified on the Plans unless it is of the specified class and waiting or parking for the purposes of loading or unloading of goods in connection with nearby trade or business premises.
15. Where there is specified in the Plans a maximum period during the restricted hours for which loading or unloading is permitted, no person shall cause or permit any vehicle to wait or park on or in any loading area,
  - a) for longer than is necessary for goods to be loaded onto or unloaded from the vehicle,
  - b) for a period longer than specified on the Plans, or
  - c) if a period less than that specified on the Plans as being the period in which the vehicle shall not return has elapsed since a previous period of parking or waiting by the same vehicle on the same side of length of road.

#### Restriction on loading and unloading

16. Save as provided in Articles 20 and 21 no person shall cause or permit any vehicle or a vehicle of a specific class to park or wait for the purpose of enabling goods to be loaded to or unloaded from the vehicle on any no loading road during the no loading hours as specified on the Plans.



### Restriction on stopping

17. Save as provided in Articles 20 and 21 no person shall cause or permit any vehicle to stop on any no stopping road or clearway during the no stopping hours as specified on the Plans.

### Emergencies

18. Nothing in Articles 10 to 17 and 29A(a) shall render it unlawful to cause or permit any emergency services vehicle to wait or park in any of the prohibited or restricted roads, lengths of road or on the sides of road or loading areas specified on the Plans for so long as may be necessary to enable the vehicle to be used in an emergency for fire and rescue, coastguard, ambulance or police purposes:

### General exemptions

19. Nothing in Articles 10 to 17 and 29A(a) shall render it unlawful to cause or permit any vehicle to wait or park in any of the prohibited or restricted roads, lengths of road or on the sides of road or loading areas specified on the Plans for so long as may be necessary to enable:
- a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
    - (i) the delivering of specialist services to, or delivering and/or collecting bulk materials or specialist materials or specialist equipment used in building, shop fitting, industrial or demolition operations;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance, improvement or reconstruction of the said lengths or sides of road; and
    - (iv) the laying, erection, alteration or repair in or on land adjacent to the said lengths or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications system,
  - (b) the vehicle, not being a passenger vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or its contractors in pursuance of that authority's statutory powers or duties;

- (c) the vehicle of the Royal Mail or other universal service provider as defined in the Postal Services Act 2000 to be used for the purpose of delivering and/or collecting mail and/or postal packet/s; or
- (d) in any case where the person in control of the vehicle,
  - (i) is required by law to stop;
  - (ii) is obliged to stop so as to prevent an accident, or
  - (iii) is prevented from proceeding by circumstances outside his/her control.

#### Loading and unloading

- 20. Nothing in Articles 14 to 16 and 29A(a) shall render it unlawful to cause or permit any vehicle to wait or park in any of the prohibited or restricted roads, lengths of road or on the sides of road specified on the Plans for so long as may be necessary to enable goods to be loaded to or unloaded from a vehicle (or goods or merchandise to be delivered or collected).

#### Board and alight from a vehicle

- 21. Nothing in Articles 10, 11, 14 and 29A(a) shall render it unlawful to cause or permit any vehicle to wait or park in any of the prohibited or restricted roads, lengths of road or on the sides of road specified on the Plans for so long as may be necessary to enable a person to board or alight from the vehicle.

#### Funerals and weddings

- 22. Nothing in Articles 10, 11, 14 and 29A(a) shall render it unlawful to cause or permit any vehicle to wait or park, if it cannot safely and conveniently do so elsewhere, in any of the prohibited or restricted roads, lengths of road or on the sides of road specified on the Plans if it is an official vehicle being used for funerals or weddings.

#### Parking places

- 23. Nothing in Articles 13 to 18 shall render it unlawful to cause or permit any vehicle to wait or park in or upon a designated parking place.

Waiting or parking by vehicle displaying a waiver, suspension or dispensation certificate

24. Nothing in Articles 13 to 20 and 29A(a) shall prevent any person from causing or permitting a vehicle to wait or park in any prohibited or restricted road if it is displaying in the relevant position a valid waiver certificate, suspension certificate or dispensation certificate issued by the Council and the vehicle is waiting and or parking in accordance with the terms and conditions of the said certificate.

Waiting or parking by disabled persons' vehicle

25. Nothing in Articles 10 and 11 shall render it unlawful to cause or permit a vehicle which displays in the relevant position a disabled person's badge and a parking disc, on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting or parking began, to wait or park in a prohibited road or a restricted road for a period not exceeding 3 hours (not being a period separated by an interval of less than that specified on the Plans from a previous period of waiting or parking by the same vehicle in the same length of road or on the same side of road on the same day) provided that the vehicle immediately before or after the act of waiting or parking has been or is about to be driven or used by the person to whom the badge has been issued or, as the case may be, used for the carrying of disabled person(s) as passenger(s).

Taxi ranks and taxi bays and Hackney carriage stands

26. Nothing in Articles 10 and 11 shall prevent any person from causing or permitting a licensed hackney carriage to stop or wait or park in any duly authorised taxi rank, taxi bay, or Hackney carriage stand during the period of operation of that taxi rank, taxi bay, or Hackney carriage stand specified on the Plans.
27. No person shall cause or permit any vehicle other than a hackney carriage to stop or wait or park on a taxi rank, taxi bay, or Hackney carriage stand during the period of operation of that taxi rank, taxi bay, or Hackney carriage stand specified on the Plans.
28. No person shall cause or permit a hackney carriage to stop or wait or park on a taxi rank, taxi bay, or Hackney carriage stand during the period of operation of that taxi rank, taxi bay, or Hackney carriage stand other than for the purpose of plying for hire.
- 29 (a) Save as provided in Articles 18 to 22, 24 and 29A(b) of this Order, no person shall, except on the direction or with the permission of a police constable in

uniform or of a civil enforcement officer, cause or permit any vehicle to wait in the areas specified on the Plans as 'No waiting (taxi rank)', during the times specified on the Plans.

- (b) Nothing in Article 29A(a) of this Order shall render it unlawful to cause or permit a licensed hackney carriage to wait in the areas referred to therein for so long as may be necessary for the purpose of plying for hire.

#### General conditions of waiting and parking

30. Save as provided in Article 40 no person shall cause or permit any vehicle to wait or park at any time unless all wheels are on the carriageway and, if conditions dictate that the vehicle should wait or park parallel to the kerb, so that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than 50cms.
31. Save as provided in Articles 21 and 22 no person shall cause or permit any vehicle to wait or park at any time so that any part of the vehicle obstructs any dropped kerb or any vehicular means of ingress to or egress from premises adjacent to the side of the road on which the vehicle is waiting or parking.

### SECTION 3 – PERMITTED PARKING PLACES

#### Parking places

##### Designation of parking places

32. The parts of roads identified as parking places on the Plans are hereby designated to be used subject to the following provisions of this Order as parking places and may be used subject to the provisions of this Order on such days, during such hours and for such durations as are specified on the Plans.
33. No person shall cause or permit any vehicle to wait or park in a parking place during the permitted hours unless it is of the specified class.

##### Classes of vehicles for which parking places are designated

34. Subject to the provisions of this Order, parking places may be used during the permitted hours only for the parking of motor cars, motor caravan, motor cycles and motor cycles with sidecar, motor tricycles, motor quadricycles and vehicles displaying a disabled persons' badge.

### Restriction on parking

35. Save as in an emergency, no person shall cause or permit any vehicle to remain in a parking place for longer than the maximum period specified for that parking place in the Plans.

### No return

36. Where a period within which a vehicle must not be parked again in a parking place is specified in the Plans, no person shall permit or cause the vehicle to park again in that parking place until the expiry of that specified period.
37. Where a period within which a vehicle must not be parked again in a parking place is specified in the Plans and that parking place lies within a controlled parking zone, no person shall permit or cause the vehicle to park again in any parking place within that controlled parking zone until the expiry of that specified period.

### Permit holders

38. A permit holder may park a vehicle of the class authorised to park in a designated parking place for any period of time, except where this order makes provision for loading and unloading only, provided that the vehicle displays in the relevant position a valid permit for parking that vehicle in that road or place.

### Verge and footway parking

39. Where parking partially or fully on the verge or footway is specified on the Plans, and indicated by the placement on signs at the location which comply with the 2016 Regulations, nothing shall render it unlawful for any person to cause or permit a vehicle of the class specified to park in a parking place partially or fully on the verge or footway as indicated.

### Payment parking places

#### Designation of pay and display parking places

40. The parts of roads identified as such on the Plans are hereby designated to be used subject to the following provisions of this Order as pay and display parking places and may be used subject to the provisions of this Order on such days and during such hours as are specified on the Plans.

41. No person shall cause or permit any vehicle to be parked in a pay and display parking place during the permitted hours unless it is of the specified class and there is displayed on that vehicle in the relevant position a pay and display ticket valid for that time and for that parking place or payment of the appropriate fee through an alternative approved method of payment has been sort and taken.

Classes of vehicles for which pay and display parking places are designated

42. Subject to the provisions of this Order, parking places may be used during the permitted hours for the parking of motor cars, motor cycles and motor cycles with sidecar, motor tricycles, motor quadricycles and vehicles displaying a disabled persons' badge.

Pay and display ticket machines to be installed at pay and display parking places

43. The Council will –
- a) install in such positions at or in the vicinity of a payment parking place as it may think fit such pay and display ticket machines as are required by this Order for the purposes of that parking place; and
  - b) carry out such other work as is authorised by this Order or is reasonably required for the purposes of the satisfactory operation of a parking place.

Maximum period of parking

44. Subject to the provisions of this Order, no person shall cause or permit any vehicle to be parked in a pay and display parking place
- a. beyond the time of expiry of the period for which the charge has been paid, or
  - b. for longer than the maximum period as specified for that parking place by notice at or close to the parking place and in Schedule 2 of this Order.

No return

45. Subject to the provisions of this Order, where a period within which a vehicle must not be parked again in the pay and display parking place as specified for that parking place by notice at or close to the parking place and in Schedule 2 of this Order no person shall permit or cause the vehicle to park again in that parking place until the expiry of that specified period.

### Payment

46. No person shall cause or permit any vehicle to be parked in a pay and display parking place without arranging for the appropriate charge (if any) to be paid in accordance with the scale of current charges as specified for that parking place in Schedule 2 of this Order and displayed by notice at or close to the parking place.

### Means of payment

47. The charge referred to in the preceding Article shall be payable in the manner as specified for that parking place by notice at or close to the parking place.
48. The person in charge of a vehicle, upon parking the vehicle in a pay and display parking place, shall immediately;
- a. purchase a ticket from a pay and display ticket machine situated close to that parking place at the level of charge and for the period required in accordance with the scale of hourly charges as specified for that parking place by notice at or close to the parking place and in Schedule 2 of this Order, or
  - b. For the areas listed in Schedule 2 of this Order and permitting limited free parking, obtain a free 30 minute parking period ticket from a pay and display ticket machine situated close to that parking place, or
  - c. make payment of the appropriate fee through an alternative approved method of payment at the level of charge, plus an administration fee, and for the period required in accordance with the scale of hourly charges as specified for that parking place by notice at or close to the parking place and in Schedule 2 of this Order.

### Display of ticket

49. Where on payment of the charge a ticket has been obtained, the person in charge of the vehicle shall
- a. display the ticket issued in a relevant position on the vehicle in respect of which it was issued, orientated so that the whole of the information on the front of the ticket is clearly legible from outside the vehicle; and

- b. ensure that the ticket is clearly and constantly displayed during the entire period that the vehicle is parked in the parking place.

#### Validity of tickets

50. A ticket is not transferable from one vehicle to another.
51. A ticket is valid only until the expiry of the period for which a charge has been paid or until the expiry of the period for which free parking has been granted.
52. A ticket is valid only in the parking place, zone or street in respect of which it was issued. This is defined by the identification on traffic signs, a pay and display ticket machine located in respect of that parking place, zone or street and the information printed on the pay and display ticket.

#### Expiry of parking period

53. The expiry of the period for which the charge has been paid shall be when the time shown on the clock of the issuing pay and display ticket machine is later than the time exhibited on the pay and display ticket displayed on the vehicle.
54. For the avoidance of doubt, the limit of waiting time applicable to a parking place shall take precedence over the times shown on a ticket in determining whether or not a contravention has taken place.

#### No ticket displayed

55. If at any time while a vehicle is parked in a parking place no ticket is displayed on that vehicle in the relevant position and where arrangements to pay the hourly charge through an alternative approved method of payment have not been made, it shall be judged that the charge has not been paid.

#### Pay and display ticket machine out of order

56. If at the time when a vehicle is parked during the permitted hours in a parking place and the nearest pay and display ticket machine is out of order, then a ticket shall be obtained from another pay and display ticket machine relative to that parking place, zone or street (where provided) or arrangements must be made to pay the appropriate fee through an alternative approved method of payment such as Park and Phone at



the level of hourly charge and for the period required in accordance with the scale of charges as advertised at that parking place plus an administration fee.

#### Restriction on removal of tickets

57. Where a ticket has been attached to a vehicle in accordance with the provisions of this Order no person, not being the driver or owner of the vehicle, a civil enforcement officer or a person authorised by the Council, shall remove the ticket from the vehicle unless authorised to do so by the driver.

#### Exemptions

##### Motorcycles

58. motorcycle parked in a designated motorcycle parking bay

##### Payment by phone or alternative approved method

59. Where arrangements to pay the hourly charge have been made through an alternative approved method of payment and no ticket is produced by following the process, the driver of a vehicle shall be exempt from the requirement to display such a ticket.

##### Permit

60. The driver of any vehicle displaying in the relevant position a permit valid for that pay and display parking place as shown in Schedule 2 shall be exempt from payment of the parking charge and display of ticket provided that the vehicle is being used in accordance with the conditions applying to the said permit.

##### Waiver, suspension and dispensation certificates

61. The driver of any vehicle displaying in the relevant position a valid waiver, suspension or dispensation certificate shall be exempt from payment of the parking charge, display of ticket and any time limit provided that the vehicle is being used in accordance with the conditions applying to the said certificate.

#### Doctor's parking places

##### Designation of doctor's parking places

62. The parts of roads identified as doctor's parking places on the Plans are hereby designated to be used subject to the following provisions of this Order as doctor's

parking places and may be used subject to the provisions of this Order on such days and during such hours as are specified on the Plans.

63. No person shall cause or permit any vehicle to park in a doctor's parking place during the permitted hours unless it is displaying in the relevant position a doctor's parking permit valid for that vehicle, that time and that parking place.
64. A doctor's parking permit will be issued by the Council in such form and subject to such conditions as may be agreed from time to time by the Council.

### **Disabled person's parking places**

#### **Designation of disabled person's parking places**

65. The parts of roads identified as such on the Plans are hereby designated to be used subject to the following provisions of this Order as parking places for vehicles displaying a valid disabled person's badge and may be used subject to the provisions of this Order on such days, during such hours and for such durations as are specified on the Plans.

#### **Display of disabled person's badge**

66. No person shall cause or permit any vehicle to park in a disabled person's parking place during the permitted hours unless there is displayed on that vehicle in the relevant position a valid disabled person's badge and provided that the vehicle immediately before or after the act of parking has been or is about to be driven or used by the person to whom the badge has been issued or, as the case may be, used for the carrying of disabled person(s) as passenger(s).

#### **Maximum period of parking in a disabled person's parking place**

67. Save as in an emergency, no person shall cause or permit any vehicle to remain in a disabled person's parking place for longer than the maximum period specified for that parking place on the Plans.
68. Where indicated on the Plans there is a maximum period specified for that disabled person's parking place, the driver of a vehicle shall upon leaving the vehicle in the parking place, display in the relevant position a disabled person's badge and a disabled person's parking disc, on which has been marked the time at which the period of

parking began and shall remove that vehicle from the said parking place within the maximum time specified.

69. Where a period within which a vehicle must not be parked again in the disabled person's parking place is specified in the Plans, no person shall permit or cause the vehicle to park again in that parking place until the expiry of that specified period.

### **Other parking places**

#### **Special classes of vehicles**

70. The parts of roads identified as such on the Plans are hereby designated to be used subject to the following provisions of this Order as parking places for specific classes of vehicles and may be used subject to the provisions of this Order on such days and during such hours as are specified on the Plans.
71. Where parking places are provided for the leaving of specific classes of vehicle with or without charge or time limit, no person shall cause or permit any vehicle to park in that parking place during the periods specified in the Plans unless it is of the class specified and where applicable on payment of any charge and
- a) for a period longer than that specified, or
  - b) where a period within which a vehicle must not be parked again in the parking place is specified in the Plans, no person shall permit or cause the vehicle to park again in that parking place until the expiry of that specified period.
72. Specific classes of vehicle include but are not limited to ambulances, Police vehicles, buses, large or slow vehicles, goods vehicles, motor cars, motor caravans and caravans drawn by motor vehicles.

### **General conditions in respect of parking places**

#### **Manner of standing in a parking place**

73. Unless indicated otherwise by markings on the carriageway, each vehicle parked in a limited waiting, pay and display, disabled person's, specific class of vehicle, and permit parking place in accordance with the foregoing provisions of this Order shall stand:

- a. if the parking place is in a one-way street, so that the vehicle is facing according to the direction of the traffic flow and adjacent to the edge of the carriageway;
- b. if the parking place is not in a one-way street, so that the left or near side of the vehicle is adjacent to the left-hand edge of the carriageway;
- c. so that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than 50cms;
- d. so that no part of the vehicle obstructs any vehicular means of ingress to or egress from premises adjacent to the side of the road on which the vehicle is parked; and
- e. so that all tyres on the vehicle lie wholly within the markings of the parking bay and not more than 300mm of the vehicle, including any load, overhangs into any adjacent parking bay.

#### Alteration of position of a vehicle in a parking place

74. Where any vehicle is standing in a parking place in contravention of the provisions of the preceding Article, a civil enforcement officer or a person authorised by the Council may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

#### Movement of a vehicle in a parking place in an emergency

75. A civil enforcement officer or a person authorised by the Council may move or cause to be moved or remove or cause to be removed, in case of emergency, to any place he / she thinks fit, any vehicle parked in a parking place and shall provide for the safe custody of the vehicle.

#### Suspension of use of a parking place

76. A person duly authorised by the Council may suspend the use of a parking place or any part thereof, or upon application grant permission to reserve for sole use any parking place or any part thereof whenever they consider such suspension reasonably necessary:
  - a) for the purpose of any building operation, demolition or excavation adjacent to the parking place, the maintenance, improvement or reconstruction of the

highway or the cleansing of gullies in or adjacent to the parking place, the laying, erection, alteration or repair in or adjacent to the parking place or any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telecommunications system or the placing, maintenance or removal of any traffic sign;

- b) for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture to or from one office or dwelling-house adjacent to the parking place from or to a depositary, another office or dwelling-house;
- c) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions;
- d) on a market day or on market days;

The above suspensions may be put in place for as long as it is reasonably necessary to complete the activities above or for a period determined by the person authorised by the Council.

77. A civil enforcement officer or a person authorised by the Council may suspend for not longer than 7 consecutive days the use of a parking place or any part thereof whenever he / she considers such suspension reasonably necessary;
- a. for the purpose of facilitating the movement of traffic or promoting its safety.
  - b. on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed;
  - c. on any occasion in the interests of traffic or pedestrian movement and safety when a special event is taking place in the vicinity;
78. A civil enforcement officer or a person authorised by the Council suspending the use of a parking place or any part thereof in accordance with the provisions of this Order shall thereupon place or cause to be placed in or adjacent to that parking place or part thereof a traffic sign, complying to the 2016 regulations or one that has special approval by DfT, indicating that parking by vehicles is prohibited and the duration of

the prohibition. The sign or signs will be placed at or near the location in advance of the prohibition coming in to force as follows:

- a. For prohibitions under Article 76 signs must be placed at least 7 days prior to the prohibition coming in to force,
- b. For prohibitions under Article 77 signs must be placed up to 7 days prior to the prohibition coming in to force.

The above signs MUST be removed as soon as possible after the prohibition has finished.

#### No parking in a suspended parking place

79. No person shall cause or permit a vehicle to park in a parking place or any part thereof during which such period as a civil enforcement officer or a person authorised by the Council has suspended that parking place or part thereof and exhibits notice of such suspension on or near that parking place.
80. Nothing in the preceding Article shall render it a contravention to cause or permit a vehicle to be parked in a parking place which has been suspended, which displays in the relevant position a valid dispensation certificate issued by the Council, and the vehicle is parking in accordance with the terms and conditions of the said certificate.

#### Restrictions on the use of vehicles in a parking place

81. During the permitted hours no person shall use any parking place or any vehicle whilst it is in a parking place
  - a. to carry out any trade,
  - b. in connection with the sale or offering or exposing for sale any goods to any person in or near the parking place, or
  - c. in connection with the selling or offering for sale of their skill in handicraft or their services in any other capacity:provided that
  - d. nothing in this Article shall prevent the sale of goods from a vehicle if there is on display in the vehicle a certificate of Street Trading Consent issued by the

Council and the vehicle is being operated in accordance with any conditions of the said certificate.

Exemptions to restriction on parking by a vehicle in a parking place

82. Notwithstanding the foregoing provisions of this Order any vehicle may be parked during the permitted hours in any part of a parking place if the use of that part has not been suspended and if:
- a) the vehicle is parked for so long as may be necessary for the purpose of enabling any person to board or alight from a vehicle or load thereon or unload therefrom their personal luggage;
  - b) the vehicle is parked owing to the driver being prevented from proceeding by circumstances beyond their control or to such parking being necessary in order to avoid an accident;
  - c) the vehicle is being used for fire and rescue, ambulance or police purposes or, not being a passenger vehicle, is being used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to park in the place in which it is parked;
  - d) the vehicle is parked for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
  - e) the vehicle of the Royal Mail or other universal postal service provider (as defined in Section 4(3) and (4) of the Postal Services Act 2000) is parked for the purpose of delivering and/or collecting mail from adjacent or nearby properties, post boxes, post offices or post office properties;

Exemptions for loading from restrictions on the use of parking places

83. Nothing in Articles 33 to 37, 41, 44 to 49, 63, 71 and 73 shall render it unlawful to cause or permit a vehicle to wait to enable goods to be loaded onto or unloaded from the vehicle, provided that vehicle is parked:-
- i) For no longer than 5 minutes without continuous loading or unloading activity;
- or,

- ii) With the consent of a police constable in uniform, a civil enforcement officer, or some other person authorised by the Council.

Exemptions for vehicles displaying a valid disabled person's badge

84. The restrictions imposed by Articles 35 to 37, 41, and 44 to 49 of this Order shall not apply to any vehicle lawfully displaying a disabled person's badge in the relevant position within the meaning of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) England) Regulations 2000 as amended.

Exemptions for vehicles displaying a valid dispensation certificate

85. Notwithstanding the foregoing provisions of this Order any vehicle displaying in the relevant position a valid dispensation certificate issued by the Council may be parked
- a. without payment of a hourly charge or time limit during the permitted hours in any part of a parking place if the use of that part has not been suspended, or
  - b. in any part of a parking place the use of which has been suspended provided that the vehicle is parked in accordance with the terms and conditions of the said certificate

Placing of traffic signs etc.

86. The Council shall:
- a) place and maintain traffic signs indicating the limits of each parking place;
  - b) place and maintain traffic signs of a design approved by the Secretary of State for the Department for Transport indicating that such parking places may be used during the permitted hours for the leaving only of the vehicles of the specified classes; and
  - c) carry out such other work as it reasonably required for the purposes of the satisfactory operation of a parking place.



## **SECTION 4 - CONDITIONS AS TO PERMITS**

### **Classes of vehicles for which permits are applicable**

87. Subject to the provisions of this Order, permits may be issued to classes of vehicles being motor cars, motor cycles and motor cycles with sidecar, motor tricycles and motor quadricycles.

### **Use of permits or scratch cards**

88. A permit or scratch card shall only be valid for use in a parking place on a road as identified on the permit or scratch card and specified on the Plans.

### **Entitlement to, Issue of and application for permits**

#### **Resident permits**

89. Any resident in a controlled parking zone or road or street as specified in Schedule 3 who is the owner of a vehicle/s of the class specified in Article 86 of this Order, may apply to the Council for the issue of a residents permit/s in respect of that vehicle/s and / or the issue of visitor permit/s for use by visitor/s to the resident up to and including any set limit on the number of permits as the Council may from time to time determine and any such application shall be made on a paper or electronic form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied together with any payment of such fee as the Council may from time to time determine.
90. Details of the number of resident permits/visitor permits permitted for each controlled parking zone or resident parking permit scheme and their costs are shown in Schedule 3.

#### **Resident visitor permits**

91. Any resident with a postal address in a controlled parking zone or road or street as specified in Schedule 3 may apply to the Council for the issue of a residents visitor permit/s for use by visitor/s, who is the owner/keeper of a vehicle of the class specified in Article 86 of this Order, to the resident up to and including any set limit on the number of visitor permits as the Council may from time to time determine and any such application shall be made on a paper or electronic form issued by and obtainable from the Council and shall include the particulars and information required

by such form to be supplied together with any payment of such fee as the Council may from time to time determine.

92. In the case of a resident who does not already have a permit the resident may apply to the Council for a registration card containing the resident's particulars. The resident will produce the registration card when applying for resident's visitor permit/s / voucher/s / permit card for use by visitor/s to the resident. An application for a registration card shall be made on a paper or electronic form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied together with any payment of such fee as the Council may from time to time determine.

#### Community Care personnel or Carer permits

93. Any carer or representative of a carer or member of an organisation approved from time to time by the Council may apply using a paper or electronic form to the Council for the issue to them of a carer permit / an essential visitor parking permit for the leaving of a vehicle of the class specified in Article 86 of this Order, in a parking place in which such permits are valid provided that the Council may require such specific and supportive information as it considers appropriate.

#### Doctor or medical practitioner permits

94. Any doctor or registered medical practitioner may apply using a paper or electronic form to the Council for the issue to them of a doctor parking permit for the leaving of a vehicle of the class specified in Article 86 of this Order, in a parking place in which such permits are valid; provided that the Council may require such specific and supportive information as it considers appropriate.

#### Nurse or Midwife permits

95. Any registered nurse or midwife may apply using a paper or electronic form to the Council for the issue to them of an essential visitor parking permit for the leaving of a vehicle of the class specified in Article 86 of this Order, in a parking place in which such permits are valid; provided that the Council may require such specific and supportive information as it considers appropriate.

### Hotels or Guest House visitor permits

96. The owner of a hotel or guest house with a postal address in a controlled parking zone may apply to the Council for a registration card (in addition to being a resident) containing the hotel / guest house particulars. The owner will produce the registration card when applying for visitor permits for use by persons occupying a bedroom at the hotel / guest house and who is the owner/keeper of a vehicle of the class specified in Article 86 of this Order, and wishes to park that vehicle within the controlled parking zone. An application for a registration card shall be made on a paper or electronic form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied together with any payment of such fee as the Council may from time to time determine.

### Discretionary permits

97. A person who or organisation that can demonstrate and provide sufficient evidence to satisfy the Council that their circumstances constitute a special case for the issuing of a permit may apply using a paper or electronic form for a permit for the leaving of a vehicle of the class specified in Article 86 of this Order, in a parking place in which such permits are valid, subject to such conditions as the Council may from time to time determine.

### Evidence in respect of application

98. The Council may at any time require an applicant for a permit or registration card to produce to an officer of the Council or authorised agent such evidence in respect of an application for a permit or registration card made to them as they may reasonably require to verify any particulars or information given to them or in respect of any permit or registration card issued by them as they may reasonably require to verify that the permit or registration card is valid.

### Issue of permits

#### Residents permits

99. Upon receipt of an application duly made under the provisions of this Order, the Council upon being satisfied that the applicant is a resident and who is the owner of a vehicle of the class specified in Article 86 of this Order, and on payment of any fee that the Council may from time to time determine, may issue to the applicant a

resident's permit for leaving the vehicle to which such residents permit relates in a parking place during the permitted hours, provided that any limit applying to the number of permits per resident or per household is not exceeded.

#### Resident visitor permits

100. Upon receipt of an application duly made under the provisions of this Order, the Council upon being satisfied that the applicant satisfies the requirements and on receipt of any fee that the Council may from time to time determine, may issue to the applicant residents visitor permits for parking of vehicle's as specified in Article 86 of this Order, during the permitted hours in a parking place to which such residents visitor permit relates a vehicle owned by a visitor to the resident, provided that any limit on the number of residents visitor permits per resident or per household applies is not exceeded.

#### Community Care personnel or Carer permits

101. Upon receipt of an application duly made under the provisions of this Order, the Council upon being satisfied that the applicant satisfies the requirements and on receipt of any fee that the Council may from time to time determine may issue to the applicant or representative of a carer a carer permit / an essential visitor parking permit for leaving during the permitted hours in a parking place the vehicle to which a permit relates provided that the Council may impose such conditions on the use of the permit as it considers appropriate and that any limit applying to the number of permits issued is not exceeded.

#### Doctor or medical practitioner permits

102. Upon receipt of an application duly made under the provisions of this Order, the Council upon being satisfied that the applicant satisfies the requirements and on receipt of any fee that the Council may from time to time determine may issue to the applicant or representative of a doctor a doctors parking permit for leaving during the permitted hours in a parking place the vehicle to which a permit relates provided that the Council may impose such conditions on the use of the permit as it considers appropriate and that any limit applying to the number of permits issued is not exceeded.

#### Nurse or Midwife permits

103. Upon receipt of an application duly made under the provisions of this Order, the Council upon being satisfied that the applicant satisfies the requirements and on receipt of any fee that the Council may from time to time determine may issue to the applicant or his/her representative an essential visitor parking permit for leaving during the permitted hours in a parking place the vehicle to which a permit relates provided that the Council may impose such conditions on the use of the permit as it considers appropriate and that any limit applying to the number of permits issued is not exceeded.

#### Hotels or Guest house permit card

104. Upon receipt of an application duly made under the provisions of this Order, the Council upon being satisfied that the applicant satisfies the requirements and on receipt of any fee that the Council may from time to time determine may issue to the applicant a permit card/s for leaving during the permitted hours in a parking place to which a permit relates a vehicle, as specified in Article 86 of this Order, and owned by a visitor to the hotel/guesthouse provided that the Council may impose such conditions on the use of the permit as it considers appropriate and that any limit applying to the number of permits issued is not exceeded.

#### Discretionary permits

105. Upon receipt of an application duly made under the provisions of this Order, the Council upon being satisfied that the applicant satisfies the requirements and on receipt of any fee that the Council may from time to time determine may issue to the applicant a discretionary parking permit for leaving during the permitted hours in a parking place the vehicle to which a permit relates provided that the Council may impose such conditions on the use of the permit as it considers appropriate and that any limit applying to the number of permits issued is not exceeded.

#### Surrender of permits

106. A permit holder may surrender a permit to the Council or authorised agent at any time and shall surrender such permit to the Council or authorised agent on the occurrence of any one of the surrender events.

### Withdrawal of permit

107. The Council or authorised agent may, by notice in writing served on the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's residence, withdraw a permit if it appears to the Council or its authorised agent that any one of the surrender events has occurred or decline to issue any permit card if any permit card has been improperly used in the past and the permit holder shall surrender the permit to the Council or authorised agent within 48 hours of the receipt of the aforementioned notice.

### Surrender events

108. Each of the following is a surrender event:
- a. the permit holder ceasing to be a resident;
  - b. the permit holder ceasing to be the named driver, owner or registered keeper of the vehicle in respect of which the permit was issued;
  - c. the vehicle in respect of which such permit was issued being adapted or used in such a manner that it is no longer a vehicle of the class specified in Article 86 of this Order;
  - d. the issue of a duplicate permit or visitor permit / voucher by the Council under the provisions of this Order;
  - e. the permit being defaced, mutilated or altered;
  - f. the permit holder ceasing to be a medical professional registered with the Nursing & Midwifery Council or a medical professional as defined in the Medical Act 1983;
  - g. the circumstances changing under which a discretionary permit was issued;

### Validity of permit

109. A permit shall cease to be valid at the expiration of the period specified thereon or on the occurrence of any of the surrender events, whichever is the earlier.
110. All permits shall be renewable annually or such other period as the Council may from time to time determine.

111. Where a permit or voucher is issued to any person upon receipt of a cheque and the cheque is subsequently dishonoured, the permit or voucher shall cease to be of any effect and the Council shall by notice in writing served on the person to whom such permit or voucher was issued by sending the same to the permit holder at the address shown by that person on the application for the permit, or at any other address believed to be that person's place of abode, require that person to surrender the permit or voucher to the Council within 48 hours of receipt of the aforementioned notice.
112. A permit shall cease to be valid if:
- a. the details have been altered or defaced;
  - b. any additional details required as a condition of the permit are not exhibited;  
or
  - c. the details cannot be easily read from outside the vehicle;

#### Duplicate permits

113. If a permit or visitor voucher is accidentally mutilated or defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall surrender it to the Council and apply to the Council for the issue of a replacement permit or voucher.
114. If a permit or visitor voucher is lost or destroyed, the permit or voucher holder may apply to the Council for the issue of a duplicate permit or voucher.
115. On application under the provisions of this Order, the Council, being satisfied as to the circumstances as indicated, and on payment of any fee as the Council may from time to time determine, shall issue a replacement or duplicate permit or voucher so marked and upon such issue the original permit or voucher shall become invalid.
116. All the provisions of this Order shall apply to a replacement or duplicate permit to the same extent as they applied to the original permit.

The conditions under Article 111, 112, 113, 114 and 115 of this Order do not apply to permit of the form described in Article 116 (b) of this Order.



### Form of permit

117. A permit shall be one of two forms;

- a. in writing and shall include the following particulars:-
  - i. the registration mark of up to two vehicles (or up to four vehicles in the case of a permit for a long stay pay and display zone) in respect of which the permit has been issued provided that in exceptional circumstances at the absolute discretion of the Council the vehicle registration mark may be omitted;
  - ii. the period during which, subject to the provisions pertaining to surrender or withdrawal, the permit shall remain valid;
  - iii. an indication that the permit has been issued by the Council;
  - iv. Authority to park in the controlled parking zone, pay and display zone or road or street as specified in Schedule 2 or 3 to which the application relates; and
  - v. a code or identification indicating the location or parking area for which the permit is valid;
- b. an electronic format permit be registered on an account in an electronic database approved by the council accessible via computer or handheld device or the permit helpline and will indicate the following particulars:-
  - i. the registration mark of the vehicle to which the permit applies. This can be varied by the holder of the permit, by use of a computer or contact with the Helpline, to any vehicle which complies with Item 86 of this Order.
  - ii. the period during which, subject to the provisions pertaining to surrender or withdrawal, the permit shall remain valid;
  - iii. Authority to park in the controlled parking zone, pay and display zone or road or street as specified in Schedule 2 or 3 to which the application relates.



#### Refund of charge paid

118. A permit holder who surrenders a permit to the Council before the permit becomes valid or after the permit becomes valid may be entitled to a refund of such proportion of the permit fee as the Council may from time to time determine.

#### Dispensation, suspension or waiver certificate

119. The Council may issue a dispensation, suspension or waiver certificate on receipt of an application and may impose charges, terms and conditions as the Council may from time to time determine.
120. A dispensation, suspension or waiver certificate may be cancelled at any time at the sole discretion of the Council and shall thereupon immediately cease to be valid. Notification of such cancellation shall be in writing served on the person to whom such certificate was issued by sending the same to the dispensation certificate holder at the address shown by that person on the application for such certificate, or at any other address believed to be that person's place of abode, require that person to surrender the said certificate to the Council within 48 hours of receipt of the aforementioned notice.

#### Virtual Parking Tickets or Permits

121 A Virtual Parking Ticket or Permit may be obtained by any of the methods provided from time to time by the council and to be valid must be registered on an account in an electronic database approved by the council and an indication that payment has been made and the parking period for which payment has been made shall either;

- a. appear on a hand-held device;
- or
- b. be obtained by a Civil Enforcement Officer contacting the service provider.

122 Without prejudice to the provisions of this Order, if at any time while a vehicle is left in a parking place referred to in this Order there is no indication as set out in article 79.1 of this Order that payment of the charge for a Parking Ticket or Permit has been made using the Virtual Parking system, or there is an indication that the parking period for which payment was made has expired, it shall be presumed, unless the contrary is proved, that either;

- a. the charge for the Parking Ticket or Permit has not been duly paid in respect of that vehicle;
- or

- b. the parking period for which payment was made had already expired.
- 123 Where a Virtual Parking Ticket or Permit has been obtained as an alternative to a Parking Ticket or Permit and remains valid, any requirement in this Order for the Parking Ticket or Permit to be displayed on the vehicle to which it relates shall not apply.
- 124 Any other provisions in this Order relating to the validity of a Parking Ticket or Permit shall, except where the context otherwise provides, apply to a Virtual Parking Ticket or Permit.

## **SECTION 5 - GENERAL**

### **General conditions of waiting or parking in unregulated situations**

121. Save as provided in Article 40 in any road or lengths of road within a Special Parking Area of the Civil Enforcement Area without any specific regulation, no person shall cause or permit any vehicle to wait or be parked unless all wheels are on the carriageway and, if conditions dictate that the vehicle should wait or be parked parallel to the kerb, so that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than 50cms.
122. In any road or lengths of road within a Special Parking Area of the Civil Enforcement Area without any specific regulation, no person shall cause or permit any vehicle to wait or be parked so that any part of the vehicle obstructs any dropped kerb or any vehicular means of ingress to or egress from premises adjacent to the side of the road on which the vehicle is waiting or parked.

### **Pedestrian crossings**

123. Nothing in the provisions of this Order shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the 1984 Act.

## **SECTION 6 - CONTRAVENTION AND PENALTY CHARGE**

### **Contravention**

124. If a vehicle is waiting or parked in a prohibited or restricted road or a parking place respectively without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable.

### Indications as evidence

125. The particulars given in any penalty charge notice served on a vehicle in contravention of any provision of this Order shall be treated as evidence in any proceedings relating to failure to pay such penalty charge.

### Restriction on removal of notices

126. Where a penalty charge notice has been attached to a vehicle in accordance with the provisions of this Order no person, not being the driver of the vehicle, a civil enforcement officer or some other person duly authorised by the Council shall remove the notice from the vehicle unless authorised to do so by the keeper of the vehicle.

### Immobilisation

127. If a vehicle is left or parked after a penalty charge has been incurred, a civil enforcement officer or a person acting under the direction of a civil enforcement officer may attach to the vehicle an immobilisation device and a notice in accordance with the provisions of the 2004 Act or any subsequent legislation so enabling and that vehicle shall only be released from the device on payment of the penalty charge along with any release fee as set out within the 2004 Act or any subsequent legislation so enabling.

### Removal of vehicle

128. Where a civil enforcement officer or a person acting under the direction of a civil enforcement officer has removed or caused to be removed a vehicle in accordance with the provisions of this Order,
- (a) he / she shall provide for the safe custody of the vehicle;
  - (b) the Council shall be entitled to recover from the person responsible such charges as set out within the 2004 Act or any subsequent legislation so enabling in respect of the removal, storage and disposal of the vehicle;
  - (c) the provisions of the 2004 Act or any subsequent legislation so enabling shall apply to the disposal of such vehicles removed by or on behalf of the Council.

129. The immobilisation or removal of a vehicle displaying in a relevant position a valid disabled person's badge shall be undertaken within the guidelines set out within the 2004 Act or any subsequent legislation so enabling.
130. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment.

#### **SECTION 7 - REVOCATIONS**

131. The orders specified in Column 1 of Schedule 4 are hereby revoked to the extent specified in Column 2 of the said Schedule.
