The East Riding of Yorkshire Council (hereinafter referred to as "the Council") in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and in pursuance of powers granted by the Secretary of State under Section 74 and Part 2 of Schedule 8 and under Paragraph 8 of the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

 This Order shall come into operation on the 14th day of April 2016 and may be cited as The East Riding of Yorkshire Council(On Street Parking Places) (Civil Enforcement) (Consolidation) (Amendment No.30) (No Waiting at Any Time and No Waiting Monday to Friday 8.15am to 9.15am and 3.15pm to 4.15pm, Parts of St Leonards Road and Elmsall Drive, Molescroft) Order 2016.

1. On the 14 April 2016 The East Riding of Yorkshire Council made this Order which will be operative from the 14 April 2016 to amend The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2014 the effect of which will be:-

- (a) To introduce a No Waiting at Any Time restriction on parts of Elmsall Drive and St Leonards Road, Molescroft.
- (b) To introduce No Waiting Monday to Friday between the hours of 8.15am and 9.15am and between the hours of 3.15pm and 4.15pm on parts of St Leonards Road, Molescroft.

2. A copy of the Order and relevant plan may be examined during normal office hours at the Beverley Customer Service Centre, Cross Street, Beverley, HU17 9BA. (Ref MG/74223)

3. If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the 14 April 2016 apply to the High Court for this purpose.
