**The Eastbourne (Prohibition of Waiting) (Consolidation No 2) Order 2008
Amendment Order 2017 No 1**

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 46, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. When this Order comes into effect;
 - (i) "The Eastbourne (Prohibition of Waiting)(Consolidation No 2) Order 2008" as amended, shall have effect except as hereinafter contained.
2. Schedule 1, Prohibition of Waiting, Part A: No waiting at any time, that this Schedule be amended as follows:
 - (i) Schedule 1 Part A, No Waiting At Any Time, delete item 460 and insert items as follows;

Eldon Road	north side	from a point 143 metres east of its junction with Glendale Avenue, eastwards for a distance of 60 metres. from a point 213 metres east of its junction with Glendale Avenue, eastwards for a distance of 83 metres.
	South side	from its junction with Willingdon Road, westwards for a distance of 75 metres from its junction with Macmillan Drive, eastwards for a distance of 160 metres from a point 188 metres east of its junction with Macmillan Drive, eastwards for a distance of 18 metres from its junction with Willingdon Road to a point 63 metres west of its junction with Long Acre Close

3. Revocations

The following parts of "The East Sussex (Various Roads in Eastbourne)(Prohibition of Waiting, Prohibition of Stopping and Waiting on School Keep Clear Markings, Disabled Persons Parking Places and Goods Vehicle Only Loading Bay) Traffic Regulation Order 2016" insofar as it relates to Schedule 2, No waiting at any time;

Eldon Road north side - From a point 65 metres east of its junction with Glendale Avenue, eastwards for a distance of 61 metres.

From a point 166 metres east of its junction with Glendale Avenue, eastwards for a distance of 87 metres.

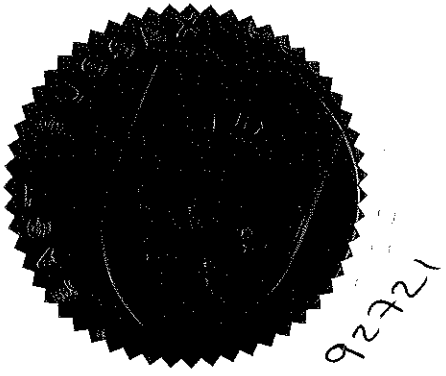
south side From the eastern kerb line of Macmillan Drive, eastwards for a distance of 158 metres

are hereby revoked.
