#### THE EAST SUSSEX (BOROUGH OF HASTINGS) (TRAFFIC REGULATION) (CONSOLIDATION) ORDER 2013 (AMENDMENT) ORDER 2015 No 1 (Part)

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

**1. When this Order comes into effect**

- (a) The East Sussex (Borough of Hastings) (Traffic Regulation) (Consolidation) Order 2013, as amended, shall have effect except as hereinafter contained.

**(i) Part 3. Sections and Schedules - that the list of locations beginning on the twelfth page of the Order, currently titled "Section One, Prohibition of Waiting At Any Time" be retitled as follows:**

Schedule One, Prohibition of Waiting At Any Time

**(ii) Schedule Forty-Two, Prohibition of Stopping on the Footway or Verge At Any Time, that this schedule be amended as follows:**

**1 Insert item 72.5 (a) 1 as follows:**

72.5	Winchelsea Lane	(a)	East Side	1	From its junction with Churchill Avenue, northwards to the boundary of Nos. 16/ 18 Winchelsea Lane.

**(iii) Section Fifty-Five, No Stopping between 8.00am and 9.30am and between 2.30pm and 4.00pm Monday to Friday on School Entrance Markings During School Term Time, that this Schedule be amended as follows:**

**1 Delete the title of this Section and insert the following title:**

Schedule Fifty-five, No Stopping between 8.00am and 9.30am and between 2.30pm and 4.00pm Monday to Friday On School Entrance markings

**2 Delete Article 1 and insert article 1 as follows:**

1	Save as provided in Article 2 below, no person shall cause or permit any vehicle to stop between the hours of 8.00am and 9.30am and between the hours of 2.30pm and 4.00pm Monday to Friday in the lengths of road specified in the Schedule to this Section.

- 3 That the list of locations following this Section and also currently titled "**Section Fifty-Five, No Stopping between 8.00am and 9.30am and between 2.30pm and 4.00pm Monday to Friday on School Entrance Markings During School Term Time**", that this list be amended as follows:

Schedule Fifty-five, No Stopping between 8.00am and 9.30am and between 2.30pm and 4.00pm Monday to Friday On School Entrance markings

- (iv) **Schedule Fifty-five, No Stopping between 8.00am and 9.30am and between 2.30pm and 4.00pm Monday to Friday on School Entrance Markings** that this schedule be amended as follows:

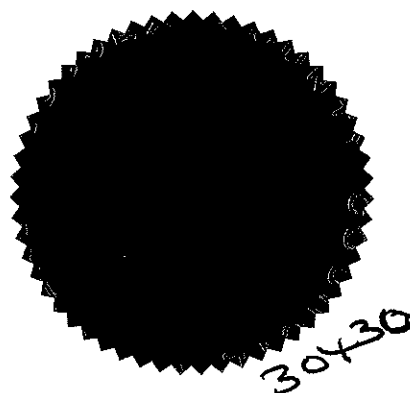
- 1 Insert item 21.5 (b) 1 as follows:

21.5	Rye Road	(b)	South-east Side	1	From a point 3 metres north east of the prolongation of the southern boundary of No.73 Rye Road, north eastwards to a point 2 metres north east of the prolongation of the boundary of Nos. 93/ 95 Rye Road.
