<u>EAST HAMPSHIRE DISTRICT COUNCIL</u> (HORNDEAN AND ROWLANDS CASTLE: VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING) AND (NO STOPPING) ORDER 2018

East Hampshire District Council hereby gives notice that pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Council of the County of Hampshire in exercise of the powers conferred on that County Council under Sections 1 (1), 2 (1), (2), 4 (2) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the third day of December 2018 and may be cited as "East Hampshire District Council (Horndean and Rowlands Castle: Various Roads) (Prohibition and Restriction of Waiting) and (No Stopping) Order 2018".
- 2. (1) In this Order -

"Civil Enforcement Officer" means a person (being a person appointed under Section 76 of the Traffic Management Act 2004 and/or under Section 63A of the 1984 Act) authorised by or on behalf of the Council to supervise any parking place and act as indicated by the use of the expression in any of the Articles in this Order;

"Council" means East Hampshire District Council;

"delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"disabled person's badge" or "blue badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 SI 682;

"Disabled Persons' Parking Place" means a area on a highway which is designated as a disabled persons' parking place and is comprised within and indicated by a road marking complying with the Traffic Signs Regulations and General Directions 2016;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986 as amended;

"**light goods vehicle**" means a vehicle, not exceeding 3.5 tonnes gross vehicle weight, which is constructed or adapted for use for the carriage of goods or burden of any description;

"loading" means the loading or unloading of goods to or from a vehicle;

- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge or a parking disc in the relevant position when and only when they are displayed in accordance with Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
- (3) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

- 3. Save as provided in Article 6 no person shall except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer cause or permit any vehicle to wait in the lengths of roads specified in the First Schedule to this Order.
- 4. Save as provided in Article 6 no person shall except upon the direction or with the permission of a police constable in uniform cause or permit any vehicle to wait in the lengths of road specified in the Second Schedule to this Order -
 - (a) for a longer period than 4 hours; or
 - (b) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same length of road.
- 5. No person shall stop any vehicle, between the hours of 8.00am and 8.45am and 1.45pm and 3.30pm, Monday to Friday inclusive, on the lengths of roads specified in the Third Schedule to this Order.
- 6. (1) Subject to the provisions in Article 7 nothing in Articles 3, 4 and 5 shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable -
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following operations namely -
 - (i) building industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance improvement or reconstruction of the said lengths of roads; or
 - (iv) the laying erection alteration or repair in or in land adjacent to the said lengths of roads of any sewer or of any main pipe or cable or other apparatus for the provision of gas water electricity or telecommunications by a utility organization attending their apparatus in pursuance of their statutory powers or duties; or
 - in pursuance of a local authority's highways management, works, maintenance, waste collection or street cleansing.
 - (c) the vehicle if it is a Universal Service Provider as defined in Section 4(3) of the Postal Services Act 2000 used for the delivering or collecting of postal packets;
 - (d) the vehicle to take in petrol oil water or air from any garage situated on or adjacent to the said lengths of roads;
 - (e) the vehicle to wait at or near to any premises situated on or adjacent to the said lengths of roads for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral; or
 - (f) the vehicle if it is being used by the emergency services in pursuance of their statutory powers or duties; or

North side:-

- From the junction with Lovedean Lane for a distance of 30.3 metres in a westerly direction.
- From a point 2 metres south of the boundary of 21/23 James Copse Road for a distance of 39 metres in a southerly and westerly direction.

South side:-

- From the junction with Lovedean Lane for a distance of 30.3 metres in a westerly direction.
- From a point opposite 2 metres south of the boundary of 21/23 James Copse Road for a distance of 39 metres in a southerly and westerly direction.

Links Lane

South side:-

 Between a point 251 metres west of its junction with the centreline of The Green (west) and a point 57 metres east of that point.

South side:-

- From the boundary of 18/20 Links Lane for a distance of 7.6 metres in an easterly direction.
- Between a point 127 metres west of the centreline of its junction with The Green (west) and a point 26 metres west of that point.
- From a point 17 metres west of the centreline of its junction with The Green (west) for a distance of 48 metres in a westerly direction.

North side:-

- From a point 29 metres east of the centreline of the junction with The Fairway for a distance of 3.5 metres east of that point.
- From a point 15 metres west of the centreline of The Fairway to the boundary of 28/24 Links Lane.

- (g) the vehicle if it is required by law to stop or obliged to stop so as to prevent an accident or prevented from proceeding by circumstances beyond its control.
- (h) the vehicle to wait for the purpose of enabling goods to be loaded on or unloaded from the vehicle.
- (2) Nothing in Articles 3, 4 and 5 shall render it unlawful to cause or permit a disabled person's vehicle which validly displays in the relevant position a disabled person's badge in the circumstances prescribed in Regulations 7, 8 or 9 and subject to the limitation set out in Regulation 6(2) of the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 SI 683 to wait in the lengths of roads referred to therein.
- 7. Those vehicles described in Article 6 (1) (a) to (h) are subject to the provision that:-
 - (a) there is no reasonable alternative place to stop or wait; and
 - (b) they only stop and wait for so long as is necessary.
- 8. No person shall stop any vehicle, at any time, on the lengths of road specified in the Fourth Schedule to this Order unless that vehicle is required by law to stop or obliged to stop so as to prevent an accident or prevented from proceeding by circumstances beyond its control.
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

FIRST SCHEDULE (Waiting prohibited at all times)

Lengths of roads in Horndean and Rowlands Castle

Bowes Hill

North-east side:-

 From a point 15 metres south of the centreline of the junction of Uplands Road for a distance of 39.3 metres in a north-westerly direction.

Broad Croft

Both sides:-

 From the centreline of Uplands Road for a distance of 14 metres in a westerly direction.

Catherington Lane

South side:-

From the boundary of 45/47
 Catherington Lane in a north-westerly direction for 26.7 metres.

Heath Close

East side:-

From the northern boundary of 18
Heath Close in a south-westerly, then
southerly and then south-easterly
direction for a distance of 32 metres.

Merchistoun Road

North side:-

 From its junction with Catherington Lane eastwards for a distance of 38 metres.

South side:-

 From its junction with Catherington Lane eastwards for a distance of 20 metres.

Murray Road

North side:-

 From a point 32 metres north-east of Catherington Lane for a distance of 12.7 metres in a north-easterly direction.

South-east side:-

 From the boundary of 18/20 Murray Road for a distance of 36 metres in a south-westerly direction.

South-west side:-

 From a point 7 metres north of its junction with Portsmouth Road in a north-westerly direction for a distance of 30 metres.

Napier Road

North side:-

 From a point 14 metres east of its junction with Murray Road for a distance of 15 metres in a northeasterly direction.

Redhill Road

North-west side:-

 From the boundary of 88/90 Redhill Road in a south-westerly direction for 96.5 metres.

Rookes Close

Both sides:-

 From its junction with Murray Road in a south-easterly direction for a distance of 10.6 metres.

Uplands Road

North-east side:-

 From the junction of Bowes Hill in a north-easterly direction for a distance of 8.7 metres.

South-east side:-

 From the junction of Bowes Hill in a north-easterly direction for a distance of 8.1 metres. Uplands Road

West side:-

 From the boundary between 18/20 Uplands Road in a northerly direction for 61 metres.

Walden Gardens

South side:-

 From a point 18.5 metres east of the junction with Catherington Lane for a distance of 11.6 metres in an easterly direction.

SECOND SCHEDULE (Waiting Limited to 4 Hours, No Return with 2 Hours)

<u>Lengths of roads in Horndean</u> and Rowlands Castle

Links Lane

South side:-

- From a point 211 metres west of its junction with the centreline of The Green (west) to a point 13 metres east of that point.
- From a point 7.6 metres east of the boundary of 18/20 Links Lane for a distance of 24.2 metres in an easterly direction.

THIRD SCHEDULE (Waiting prohibited between the hours of 8.00am and 8.45am and 1.45pm and 3.30pm Monday to Friday inclusive)

<u>Lengths of roads in Horndean</u> <u>and Rowlands Castle</u>

Walden Gardens

North side:-

 From a point 30.1 metres east of the junction with Catherington Lane for a distance of 38.2 metres in an easterly direction.

South side:-

 From a point 26.5 metres east of the junction with Catherington Lane for a distance of 40.2 metres in a north-easterly direction.

FOURTH SCHEDULE (No Stopping on School Markings at Any Time)

<u>Lengths of roads in Horndean</u> and <u>Rowlands Castle</u>

Merchistoun Road

North side:-

 From a point 16 metres east of its boundary between 1/3 Cunningham Road, east and northwards for a total distance of 25.6 metres following the kerb line.

South side:-

 From a point 5.5 metres west of its boundary between 15/16
 Merchistoun Road, south-westwards for a distance of 43.6 metres.
