The East Sussex (Lewes District) ~~Prohibition of Waiting~~ Traffic Regulation Order 2010, Amendment
Order 2013 No.1

East Sussex County Council in exercise of their powers under sections 1(1) and (2), and 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 49, 51, 52, 53 and 63A of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a) ("the Act"), as amended, and sections 43, and 63 to 79 inclusive and Schedule 3 to the Road Traffic Act 1991(b), and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part II of Schedule 9 to the Act, hereby make the following Order:-

1. When this order comes into effect, "The East Sussex (Lewes District Prohibition of Waiting) Traffic Regulation Order 2010" shall have the effect insofar as the following provisions (which are shown in *italic*) are amended, introduced or revoked:

(a) In article 1 (h) – the addition of Schedule 3, Part G, Limited Time Prohibition of Waiting, 2 hours in any period of 4 hours, 9am to 4pm on Mondays to Friday's 1st September to 31st May is to be amended to:-

Schedule 3, Part G, Time Limited Waiting, 9am to 4pm Monday to Friday, maximum stay 2 hours, no return within 1 hour, 1st September to 31st May inclusive.

(b) In article 1 (i) – the addition of Schedule 3, Part H, Limited Time Prohibition of Waiting, 4 hours in any period of 8 hours, 9am to 4pm on Mondays to Friday's 1st September to 31st May is to be amended to:-

Schedule 3, Part H, Time Limited Waiting, 9am to 4pm Monday to Friday, maximum stay 4 hours, no return within 1 hour, 1st September to 31st May inclusive.

The following are revoked:-

Falmer – 1 (a) (ii)

And the following are introduced:-

Falmer

1. Middle Street

(a) North side

(ii) from a point 6 metres west of the western boundary of No.43 Middle Street for a distance of 25.5 metres in a westerly direction.

3. Ridge Road

(a) East side

(i) from a point opposite a point 14 metres south of its junction with Mill Street for a distance of 98 metres in a southerly direction.

(c) In article 1 (j) – the addition of Schedule 3, Part I, Limited Time Prohibition of Waiting, 4 hours in any period of 6 hours, 9am to 5pm on Mondays to Friday's is to be amended to:-

Schedule 3, Part I, Time Limited Waiting, 9am to 5pm Monday to Friday, maximum stay 4 hours, no return within 1 hour.

2. When this order comes into effect, "The East Sussex (Lewes District Prohibition of Waiting) Traffic Regulation Order 2010" shall have the effect to the Order it amends "The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1" insofar as the following provisions (which are shown in italic) are amended, introduced or revoked:

(a) Amend article 5 to:

Notwithstanding the foregoing provisions of this Order, a vehicle which displays in the relevant position a valid disabled person's badge and a time clock, may be left in any part of a street or length of street specified in any Part of Schedule 1, 2 or 3 for a period of not more than 3 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road), provided that:-

(a) the driver of the vehicle or other person in charge of the vehicle sets the time clock to the time at which the period of waiting has begun;

(b) the part of the street or length of street in which the vehicle is left is not part of a street or length of street specified in any Part of Schedule 4; and

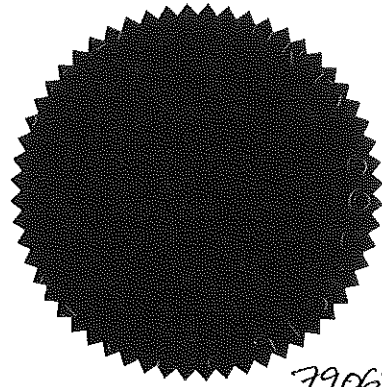
(c) the vehicle is not causing obstruction or inconvenience to other road users, including pedestrians.

(b) Amend article 13 (1) to:


Notwithstanding the foregoing provisions of this Order, a vehicle which displays in the relevant position a valid disabled person's badge may be left in a parking place referred to in Schedule 6, 7 or 8, provided that the use of that part of the parking place in which the vehicle is left has not been suspended.

3. This Order may be cited as "The East Sussex (Lewes District Prohibition of Waiting) Traffic Regulation Order 2010, Amendment Order 2013 No.1" and shall come into operation on 3 September 2013.
