The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No 1 (Amendment No 1) 2024

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 46, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. Commencement and citation

This Order may be cited as "The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No 1 (Amendment No 1) 2024 and shall come into effect on 22 July 2024

2. When this Order comes into effect:

(a) The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1, as amended, shall have effect except as hereinafter contained.

(i) The Interpretation shall be amended as follows:

1. Insert the following definitions shall be inserted between the definitions for "business user" and "carriageway":

"car club" means a car club or similar organisation (including any person or organisation acting on behalf of such club or organisation) approved in writing by the Council for the purposes of this order;

"car club parking place" means an area on a carriageway designated as a car club parking place by Schedule Twenty-One of this order;

"car club vehicle" means a vehicle of a type approved by the Council and provided by a car club or by the Council for the use of persons who have paid any relevant membership or other car club charge and who clearly and continuously display a car club permit approved by the Council in the vehicle;

2. Insert the following definitions shall be inserted between the definitions for "relevant position" and "parking place"

"parking area" means a parking place authorised by this Order;

(ii) Part III - Parking Places Designation and Authorisation of Parking Places and Supplementary Provisions. That this be amended as follows:

1. Insert Article 9 (6) as follows:

9	(6)	(i)	Each parking place referred to in Schedule 21 may be used, subject to the provisions of this Order, for the leaving during the permitted hours of such vehicles as display a valid Car Club permit.

2. Insert Article 9 (7) as follows:

9	(7)	(i)	Each parking place referred to in Schedule 22 may be used, subject to the provisions of this Order, for the leaving during the permitted hours of vehicles of the following class, that is to say, passenger vehicles of not more than 2.28 metres in height, goods carrying vehicles, motor cycles or invalid carriages

(iii) Schedule 1, Part A, Prohibition of Waiting At Any Time, that this Schedule be amended as follows:

1. In the list of restrictions for Newhaven, the following items shall be deleted as follows:

Fort Road	South-west Side	From a point 75 metres from its junction with Court Farm Road, south-eastwards to a point 6.5 metres south-east of the boundary of Nos. 1/4 and 5/8 Mariners Wharf
Marshall Lane	Both Sides	From its junction with Meeching Road, south-westwards for a distance of 4 metres.
Marshall Lane	North-west Side	From a point 4 metres south-west of its junction Meeching Road, south-westwards for a distance of 20 metres.
Marshall Lane	North-west, South-west and South Side	From a point 24 metres south-west of its junction with the north-western kerbline of Meeching Road, south-westwards, south-eastwards and north-eastwards to a point 45 metres south-west of the south-eastern kerbline of Meeching Road.
Marshall Lane	South-east Side	from a point 24 metres south-west of its junction with Meeching Road, south-westwards and south-eastwards to a point 40 metres south-west and south-east of its junction with Meeching Road.

2. In the list of restrictions for Newhaven, the following items shall be added as follows:

Fort Road	South-west Side	From a point 133 metres from its junction with Court Farm Road, south-eastwards to a point 6.5 metres south-east of the boundary of Nos. 1/4 and 5/8 Mariners Wharf
Marshall Lane	Both Sides	For its entire length

3. In the list of restrictions for Newick, the following items shall be added as follows:

Allington Road	Both Sides	From a point 9 metres north-east of the prolongation of the boundary between No. 2 Allington Road and No. 18 Church Road, north-eastwards to its junction with Church Road
Church Road	West Side	From a point 5 metres north-west of the south-eastern building line of Flat 1 The Bannisters, north-westwards for a distance of 19 metres

4. In the list of restrictions for Peacehaven, the following items shall be added as follows:

Glynn Road	Both Sides	From a point 8 metres south-east of the prolongation of the boundary between Nos. 2/4 Glynn Road, to its junction with Pelham Rise
Pelham Rise	West Side	From a point 24 meters north-east of the prolongation of the boundary between Nos. 1/3 Glynn Road, north-eastwards for a distance of 31 metres

5. In the list of restrictions for Ringmer, the following items shall be added as follows:

Bishops Lane	East Side	From its junction with Lewes Road, north-westwards for a distance of 9.5 metres
Bishops Lane	West Side	From its junction with Lewes Road, north-eastwards and north-westwards for a distance of 11 metres

6. In the list of restrictions for Seaford, the following items shall be removed as follows:

Esplanade	South-west side	From a point opposite the south eastern kerblines of Martello Road, north-westwards for a distance of 21 metres
Esplanade	South-west Side	From its junction with Martello Road, south-eastwards for a distance of 105 metres

7. In the list of restrictions for Seaford, the following item shall be added as follows:

Esplanade	South-east side	From the north-west building line of No.17 Esplanade south-eastwards for a distance of 182 metres

(iv) Schedule 3 – Limited Time Prohibition of Waiting, Part B, 8am to 6pm Monday to Saturday inclusive, maximum stay 2 hours, no return within 1 hour that this Schedule be amended as follows:

1. In the list of restrictions for Seaford, the following item shall be deleted as follows:

Pelham Road	West Side	From a point opposite a point 10.6 metres south of the northern boundary of No.8 Pelham Road, southwards for a distance of 4.4 metres.

(v) Schedule 3 – Limited Time Prohibition of Waiting, Part J, 9am to 5pm Monday to Friday, maximum stay 4 hours, no return within 2 hours that this Schedule be amended as follows:

1. In the list of restrictions for Newhaven, the following item shall be inserted as follows:

Fort Road	South-west Side	From a point 160 metres south-west of its junction with Court Farm Road, south-eastwards for a distance of 85 metres

(vi) Schedule 6, Part A, Disabled Persons' Parking Places

1. In the list of restrictions for North Chailey, the following items shall be added as follows:

Downs View	South-east Side	From a point 1.5metres north-east of the prolongation of the boundary of Nos. 10/11, north-eastwards for a distance of 6.6 metres

(vii) Schedule 7, Part A, Free Parking Places, Waiting Limited to 12 hours in any one day — No Caravans that this Schedule be amended as follows:

1. In the list of restrictions for Seaford, the following items shall be deleted as follows:

Esplanade	South-west Side	Perpendicular to the kerb, from a point 7 metres north-west of the north-west kerbline of Edinburgh Road north-westwards to a point 28 metres south-east of the south-east kerbline of Claremont Road, a distance of approximately 336 metres.
Esplanade	South-west Side	In line with kerb, from a point 15 metres south-east of the south-east kerbline of The Causeway south-eastwards to the south-eastern boundary of No.35, a distance of approximately 150 metres.
Esplanade	South-west Side	In line with kerb, from a point 15 metres south-east of the south-east kerbline of Dane Road south-eastwards to a point 15 metres north-west of the north-west kerbline of West View, a distance of approximately 239 metres.
Esplanade	South-west Side	In line with kerb, from a point 15 metres south-east of the south-east kerbline of West View south-eastwards to a point 15 metres north-west of the north-west kerbline of The Causeway, a distance of approximately 103 metres.
Marine Parade	South-west Side	In echelon, from a point 38 metres north-west of the north-west kerbline of Dane Road north-westwards for a distance of 52 metres.

Marine Parade	South-west Side	In echelon, from a point 103 metres north-west of the north-west kerbline of Dane Road north-westwards for a distance of 63 metres.
Marine Parade	South-west Side	In echelon, from a point 60 metres south-east of the south-east kerbline of Edinburgh Road south-eastwards for a distance of 60 metres.
Marine Parade	South-west Side	In echelon, from a point 133 metres south-east of the south-east kerbline of Edinburgh Road south-eastwards for a distance of 89 metres.
Marine Parade	South-west Side	From a point 6 metres south-east of the north-west kerbline of Edinburgh Road south-eastwards for a distance of 52 metres.

(viii) Schedule 7, Part B, Free Parking Places, Waiting Limited to 12 hours no return within 2 hours — that this Schedule be added as follows:

1. In the list of restrictions for Seaford, the following items shall be added as follows:

Esplanade	South-west Side	In line with kerb, from a point 15 metres south-east of the south-east kerbline of The Causeway, south-eastwards to the south-eastern boundary of No.35
Esplanade	South-west Side	In line with kerb, from a point 15 metres south-east of the south-east kerbline of Dane Road south-eastwards to a point 21 metres north-west of the north-west kerbline of West View
Esplanade	South-west Side	In line with kerb, from a point 21 metres south-east of the south-east kerbline of West View, south-eastwards to a point 15 metres north-west of the north-west kerbline of The Causeway
Marine Parade	South-west Side	In echelon, from a point 38 metres north-west of the north-west kerbline of Dane Road, north-westwards for a distance of 52 metres
Marine Parade	South-west Side	In echelon, from a point 103 metres north-west of the north-west kerbline of Dane Road, north-westwards for a distance of 63 metres
Marine Parade	South-west Side	In echelon, from a point 60 metres south-east of the south-east kerbline of Edinburgh Road, south-eastwards for a distance of 60 metres
Marine Parade	South-west Side	In echelon, from a point 133 metres south-east of the south-east kerbline of Edinburgh Road, south-eastwards for a distance of 89 metres
Marine Parade	South-west Side	From a point 6 metres south-east of the north-west kerbline of Edinburgh Road, south-eastwards for a distance of 52 metres
Marine Parade	South-west Side	Perpendicular to the kerb, from a point 7 metres north-west of the north-west kerbline of Edinburgh Road, north-westwards to a point 28 metres south-east of the south-east kerbline of Claremont Road

(ix) Schedule 14, Part C, Taxis Only Mondays to Saturdays 8am-6pm that this Schedule be amended as follows:

1. In the list of restrictions for Seaford, the following items shall be deleted as follows:

Broad Street	North-east Side	From a point 1.5 metres north-west of the north-western boundary of No. 4 Shepway Parade, Broad Street, south-eastwards for a distance of 21 metres

2. In the list of restrictions for Seaford, the following items shall be deleted as follows:

Pelham Road	West Side	From a point 15 metres south of the south-western kerb line of Dane Road southwards for a distance of 38 metres.

1. In the list of restrictions for Seaford, the following items shall be added as follows:

Broad Street	North-east Side	From a point 1.5 metres north-west of the north-western boundary of No. 4 Shepway Parade, Broad Street, south-eastwards for a distance of 21 metres

(xiii) Schedule 19, Part C, No Stopping, Mondays to Fridays, 7am-4pm, (except August) that this Schedule be amended as follows:

1. In the list of restrictions for Peacehaven, the following items shall be added as follows:

Cripps Avenue	West Side	From a point 3.9 metres north-east of the prolongation of the boundary of Nos. 10A/12, north-eastwards for a distance of 25.56 metres

(xiv) Schedule 19, Part D, School Keep Clear Marking, No Stopping, Mondays to Fridays, 8am- 5pm on entrance markings that this Schedule be added as follows:

1. In the list of restrictions for Kingston, the following items shall be added as follows:

Wellgreen Lane	North Side	From a point 1.5 metres south-east of the prolongation of the boundary of Nos. 11/12 Gowscroft Wellgreen Lane, south-eastwards for a distance of 25.56 metres
Wellgreen Lane	North Side	From a point 7 metres south-east of the prolongation of the boundary of Nos. 13/14 Gowscroft Wellgreen Lane, south-eastwards for a distance of 25.56 metres

(xv) Schedule 21, Part A, Car Club Bay At Any Time that this Schedule be added as follows:

1. In the list of restrictions for Peacehaven, the following items shall be added as follows:

Meridian Way	North-west Side	From a point 15 metres from its junction with Greenwich Way north-eastwards for a distance of 6.6 metres.

(xvi) Schedule 22, Part A, Parking Area Limited to 12 hours no return within 2 hours that this Schedule be added as follows:

1. In the list of restrictions for Seaford, the following items shall be added as follows:

Esplanade	South-east Side	From the south-eastern boundary of No. 35 south-eastwards for a distance of 132 metres.
