The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1 (Amendment No 3)(Seaford) 2019

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 46, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. (a) This Order may be cited as "The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No. 1 (Amendment No 3) (Seaford) 2019 and shall come into effect on 24th June 2019.
- (b) The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1, as amended, shall have effect except as hereinafter contained:

(i) Schedule 1, Part G, Prohibition of Waiting 8.30am - 9.30am and 2.30pm - 3.30pm Monday to Friday, that this Schedule be added as follows:

1. In the List of Schedules add Part G to Schedule 1 Prohibition of Waiting 8.30am-9.30am and 2.30pm-3.30pm Monday to Friday
2. In the list of restrictions, the following items shall be added for Seaford as follows:

Seaford

Barn Rise	north east side	from its junction with Lexden Drive north-eastwards for a distance of 32 metres
	south- east side	from a point 4 metres southwest of the property boundary of Nos.75 and 77 Barn Rise south-westwards to its junction with Barn Rise
Jubilee Gardens	north-west side	from its junction with Lexden Drive south-westwards for a distance of 12 metres
	south-east side	from its junction with Lexden Drive south-westwards for a distance of 13 metres
Lexden Drive	north-east side	from its junction with Barn Rise south-eastwards for a distance of 54 metres.
		from a point 4 metres southeast of the property boundary of Nos.39 and 41 Lexden Drive south-eastwards to its junction with Barn Rise

	south-west side	from its junction with Jubilee Gardens south-eastwards for a distance of 45 metres
		from its junction with Jubilee Gardens north-westwards for a distance of 16 metres
Pitt Drive	both sides	from the junction with Lexden Drive for its entire length.

(ii) Schedule 19 Prohibition of Stopping on 'School Keep Clear' markings 8.00am - 9.30am and 2.45pm - 4.00pm Monday to Friday (except August) as follows:

1. In the list of restrictions the following item shall be added as follows:

Seaford

Lexden Road	south west side	from a point opposite a point 2 metres north-west of the boundary of Nos.80 and 82 Lexden Road north-westwards for a distance of 33 metres.
