**The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005
No.1 Amendment Order 2017 No. 1**

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 46, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. (a) This Order may be cited as "The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1. Amendment Order 2017 No.1 and shall come into effect on 23rd June 2017.
- (b) The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1, as amended, shall have effect except as hereinafter contained.

(i) Schedule 1, Part A, Prohibition of Waiting At Any Time, that this Schedule be amended as follows:

1. In the list of restrictions for Seaford, the following items shall be added as follows:

Alfriston Road	west side	from a point 72 metres south east of its junction with the south eastern kerbline of Hindover Road, southwards and south eastwards to its junction with A259 Sutton Road.
Bromley Road	east side	from its junction with Sandore Road, northwards for a distance of 12.5 metres.
Bromley Road	west side	from its junction with Sandore Road, northwards for a distance of 12 metres.
Harrison Road	both sides	from its junction with Sandore Road, southwards for a distance of 10 metres.
Sandore Road	north side	from its junction with Bromley Road, eastwards for a distance of 14 metres.
Sandore Road	south side	from its junction with Harrison Road, eastwards for a distance of 36 metres.

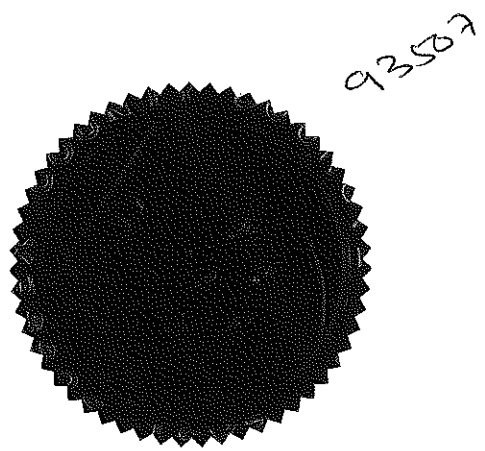
