ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND ROAD MARKINGS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of indicating restrictions on waiting and loading in the Causton restricted parking zone, Eastleigh Borough Council, hereby:-

1. authorises the erection at or within 5 metres of the sites marked with a blue cross on the attached plan numbered GT46/45/127(Pt1)-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown at R1 in the attached schedule of drawings numbered GT46/45/127(Pt1)-2; and
2. authorises the erection at appropriate sites within the said zone of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown at R4 in the said schedule of drawings; and
3. directs that the authorised sign B shall be erected in sufficient numbers to give adequate information to road users of the waiting restrictions in force in the said zone; and
4. directs that it is a condition of this authorisation that the authorised signs A and B may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and

5. directs, without prejudice to any statutory provisions to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect; and
6. directs that, notwithstanding anything to the contrary contained in the preceding paragraph, the authorised signs A and B shall be retained no longer than 2 years from the date of this authorisation.

The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part 1 of SI 2002/3113, "the 2002 Regulations") shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 663 in Schedule 2 to those Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in diagram 637.2 in Schedule 2 to those Regulations.

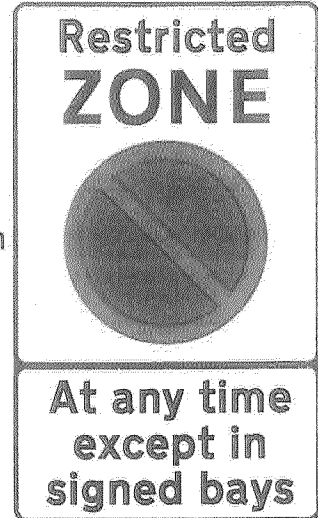
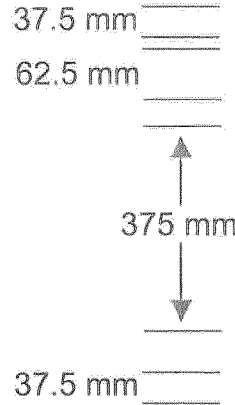

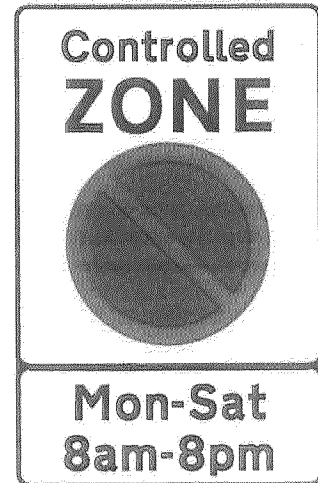
R1. Zone entry

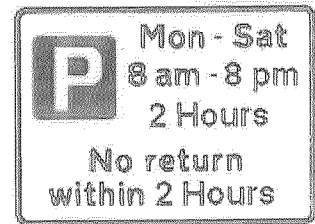
