The Eastleigh Borough Council (hereinafter referred to as "the Council") in exercise of their powers under section 35(1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and with the consent of the Hampshire County Council in accordance with section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. COMMENCEMENT AND CITATION

This Order shall come into operation on the 2nd April, 1991 and may be cited as The Borough of Eastleigh (Eastleigh Town Centre) Off-Street Car Parks (Amendment) Order 1991.

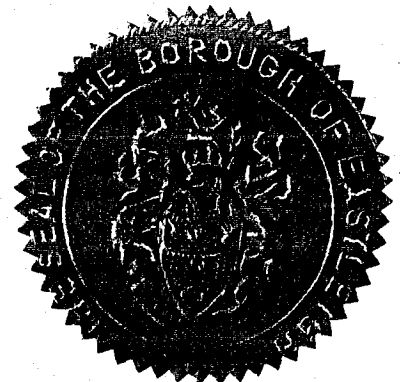

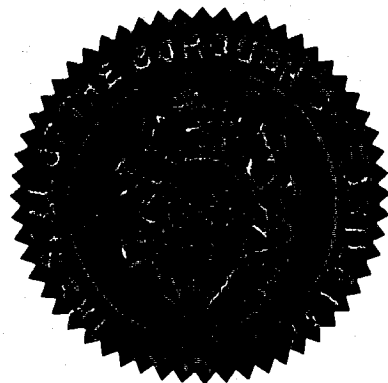
