## THE BOROUGH OF EASTLEIGH (NEWTOWN ROAD AREA) (RESIDENTS PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (FIRST ZONE) (CONTROLLED ZONE) (AMENDMENT NO.2) ORDER 2006

## Commencement and Citation

 This Order shall come into operation on 12 May 2006 and may be cited as "The Borough Of Eastleigh (Newtown Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (First Zone) (Controlled Zone) (Amendment No.2) Order 2006"

## Prohibition and Restriction of Waiting

- 2. In this Order the Principle Order means The Borough Of Eastleigh (Newtown Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (First Zone) (Controlled Zone) Order 2004
- 3. The Principle Order is hereby amended as follows:
  - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 20 shall be revoked and replaced with:

20.	Mill Street	North	From a point 1 metre west of the western boundary of No. 25 Mill Street eastwards to the western boundary of No. 16 Mill Street.
