

THE BOROUGH OF EASTLEIGH (BISHOPSTOKE, FAIR OAK AND
HORTON HEATH) (PROHIBITION AND RESTRICTION OF WAITING)
(DISABLED PERSONS PARKING PLACES)
(AMENDMENT NO.1) ORDER 2006

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 12 May 2006 and may be cited as the "Borough of Eastleigh (Bishopstoke, Fair Oak and Horton Heath) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Amendment No.1) Order 2006".

Prohibition and Restriction of Waiting

2. In this Order the Principle Order means The Borough of Eastleigh (Bishopstoke, Fair Oak and Horton Heath) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) Order 2004
3. The Principle Order is hereby amended as follows:

- (a) In the First Schedule (No Waiting at Any Time) item number 27 relating to Hamilton Road shall be revoked and replaced with:

27	Hamilton Road	Both	From a point 6 metres east of the eastern boundary of No.156 Hamilton Road eastwards to the eastern boundary of No.164 Hamilton Road.

- (b) In the Second Schedule (No Waiting- Monday to Saturday 8am to 6pm) item number 1 relating to Mainstream Court shall be revoked.
 - (c) In the Fifth Schedule (Areas on the Highway Designated as Disabled Person Parking Places) item number 3 relating to Summerlands Road shall be revoked.
