

THE BOROUGH OF EASTLEIGH (DERBY ROAD AREA) (RESIDENTS
PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING)
(DISABLED PERSONS PARKING PLACES) (THIRD ZONE) (CONTROLLED
ZONE) (AMENDMENT NO.2) ORDER 2006

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 12 May 2006 and may be cited as "The Borough Of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.2) Order 2006"

Prohibition and Restriction of Waiting

2. In this Order the Principle Order means The Borough Of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) Order 2004

3. The Principle Order is hereby amended as follows:

- (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 7 (relating to Cranbury Road) shall be revoked and replaced with:

- (b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 22 (relating to Grantham Road) shall be revoked.

(c) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 25 (relating to High Street) shall be revoked and replaced with:

25.	High Street	West	From the northern boundary of No. 107 High Street southwards to a point 8.5 metres north of the southern boundary of No. 159 High Street.

(d) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 34 (relating to Market Street) shall be revoked and replaced with:

34.	Market Street	Echelon parking bays at southern closed end	Central and eastern bays.

(e) In the Third Schedule (No Waiting at Any Time) item number 6 (relating to Chamberlayne Road), shall be deleted.

(f) In the Third Schedule (No Waiting at Any Time) item number 16 (relating to Cranbury Road) shall be revoked and replaced with:

16.	Cranbury Road	West	From the northern boundary wall of No. 217 Cranbury Road northwards to the northern closed end of the road.

16A.	Cranbury Road	East	From the northern boundary wall of No. 162 Cranbury Road northwards to the northern closed end of the road.

(g) In the Third Schedule (No Waiting at Any Time) item number 28 (relating to Desborough Road) shall be revoked and replaced with:

28.	Desborough Road	West	From a point 8 metres south of the northern closed end southwards to a point 3 metres south of the southern boundary wall of No. 233 Desborough Road.

28A. Desborough Road Northern Closed End From a point 5 metres west of the eastern kerbline westwards for a distance of 5.5 metres.

(h) In the Third Schedule (No Waiting at Any Time) item number 62 (relating to Market Street) shall be revoked and replaced with:

62. Market Street West From a point 6.5 metres south of the southern boundary wall of No. 301 Market Street southwards to the southern boundary wall of No. 313 Market Street.

(i) In the Third Schedule (No Waiting at Any Time) after item number 66 there shall be inserted:

66A. Meadow Lane Both For its entire length, including the closed ends of the road.

(j) In the Third Schedule (No Waiting at Any Time) item number 70 (relating to Un-named road between Chamberlayne Road and Desborough Road, running parallel and to the south of Grantham Road) shall be deleted.

(k) In the Fourth Schedule (No Waiting 8.00am- 8.00pm Monday to Saturday) after item number 12 there shall be inserted:

12A. Cranbury Road East From a point 9.5 metres north of its junction with Cherbourg Road northwards for a distance of 32.5 metres.

(l) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am- 8.00pm Monday to Saturday) after item number 8 there shall be inserted:

8A. Desborough Road West From the northern closed end southwards for a distance of 8 metres.

(m) In the Sixth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) after item number 2 there shall be inserted:

2A.	Cranbury Road	West	From the northern boundary of No. 227 Cranbury Road southwards for a distance of 6.5 metres.	Within the bay marked by white lines	Disabled persons vehicles	All Days	All Hours
2B.	High Street	West	From a point 2 metres north of the southern boundary of No. 159 High Street northwards for a distance of 6.5 metres.	Within the bay marked by white lines	Disabled persons vehicles	All Days	All Hours
2C.	Market Street	West	From the southern boundary of No. 301 Market Street southwards for a distance of 6.5 metres.	Within the bay marked by white lines	Disabled persons vehicles	All Days	All Hours
2D.	Market Street	Echelon parking bays at southern closed end	Western bay.	Within the bay marked by white lines	Disabled persons vehicles	All Days	All Hours
