

THE BOROUGH OF EASTLEIGH (CAMPBELL ROAD AREA) (RESIDENTS
PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING)
(DISABLED PERSONS PARKING PLACES) (SIXTH ZONE) (CONTROLLED
ZONE) (AMENDMENT NO.2) ORDER 2006

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 12 May 2006 and may be cited as "The Borough Of Eastleigh (Campbell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Sixth Zone) (Controlled Zone) (Amendment No.2) Order 2006"

Prohibition and Restriction of Waiting

2. In this Order the Principle Order means The Borough Of Eastleigh (Campbell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Sixth Zone) (Controlled Zone) Order 2004

3. The Principle Order is hereby amended as follows:

(a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 12 (relating to Campbell Road) shall be revoked and replaced with:

| 12A. | Campbell Road | Northeast | From a point 6 metres southeast of the north-western boundary of No. 17 Campbell Road south-eastwards to the south-eastern boundary of No. 21 Campbell Road. |

(b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 22 (relating to Unnamed cul-de-sac adjacent to Nos. 36 and 75 Campbell Road) shall be revoked and replaced with:

22. Unnamed cul-de-sac adjacent to Nos. 36 & 75 Campbell Road Northwest From a point 10 metres southwest of the junction with Campbell Road south-westwards for a distance of 21 metres.

(c) In the Third Schedule (No Waiting at Any Time) item number 22 (relating to Unnamed cul-de-sac adjacent to Nos, 36 & 75 Campbell Road) shall be deleted.

(d) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am- 8.00pm Monday to Saturday) item number 3 (relating to Unnamed cul-de-sac adjacent to Nos. 36 & 75 Campbell Road) shall be revoked and replaced with:

3. Unnamed cul-de-sac adjacent to Nos. 36 & 75 Campbell Road Northwest From a point 10 metres northeast of the junction with Campbell Road north-eastwards for a distance of 19 metres.

(e) In the Sixth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) after item number 1 there shall be inserted:

1A.	Campbell Road	Northeast	From a point 0.5 metres northwest of the north-western boundary of No. 17 Campbell Road south-eastwards for a distance of 6.5 metres.	Within the bay marked by white lines	Disabled persons vehicles	All Days	All Hours
