The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 12 May 2006 and may be cited as "The Borough Of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) (Amendment No.2) Order 2006"

Prohibition and Restriction of Waiting

- In this Order the Principle Order means The Borough Of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) Order 2004
- 3. The Principle Order is hereby amended as follows:
 - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 8 (relating to Cheriton Road) shall be revoked and replaced with:

8.	Cheriton Road	Northwest	From the south-western closed end north- eastwards for a distance of 12 metres.
8A.	Cheriton Road	Northwest	From the north-eastern property wall of No. 18 Cheriton Road south-westwards for a distance of 9 metres.

(b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 19 and 21 (relating to Doncaster Road) shall be revoked and replaced with:

 - (c) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 26 and 28 (relating to Mansbridge Road) shall be revoked and replaced with:

26. Mansbridge Road Northeast From a point 28 metres southeast of the junction with Chestnut Avenue south-eastwards for a distance of 11 metres.

(d) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 33 and 34 (relating to Tichborne Road) shall be revoked and replaced with:

33. Tichborne Road Southwest From a point 0.3 metres southeast of the north-western boundary wall of No. 10 Tichborne Road south-eastwards to a point 5.9 metres northwest of the south-eastern boundary wall of No. 2 Tichborne Road.

(e) In the Third Schedule (No Waiting at Any Time) after item number 6 there shall be inserted:

6A. Cheriton Road Southeast From the junction with Tichborne Road southwestwards to the closed end of the road.

(f) In the Third Schedule (No Waiting at Any Time) item number 19 (relating to Doncaster Road) shall be revoked and replaced with:
