### THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE) (PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (AMENDMENT NO.7) ORDER 2006

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

#### Commencement and Citation

1. This Order shall come into operation on 12 May 2006 and may be cited as the "Borough of Eastleigh (Eastleigh Town Centre) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Amendment No.7) Order 2006".

#### Prohibition and Restriction of Waiting

- 2. In this Order the Principle Order means The Borough of Eastleigh (Eastleigh Town Centre) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) Order 2004
- 3. The Principle Order is hereby amended as follows:
  - (a) In Article 3 after paragraph (c) there shall be inserted:
    - (d) between the hours of 8.00am and 8.00pm on any day other than a Sunday in the roads, on the sides of roads or in any lengths of roads specified in the Fifteenth Schedule to this Order.
  - (b) In the First Schedule (No Waiting at Any Time) item number 2 relating to Allbrook Hill shall be revoked and replaced with:
- Allbrook Hill 2

North

From a point 45 metres southeast of its junction with Pitmore Road to a point 75 metres west of that junction.

(c) In the First Schedule (No Waiting at Any Time) after item number 53D (relating to Ford Avenue) there shall be inserted:

53E Falkland Road

Northwest From its junction with Chestnut Avenue northeastwards to its junction with the retail park access road.

- 53F Falkland Road Southeast From its junction with Chestnut Avenue northeastwards to its junction with Tollgate.
  - (d) In the First Schedule (No Waiting at Any Time) after item number 125 there shall be inserted:

125A St Catherines Road

Both

From its junction with Twyford Road westwards for a distance of 38 metres, including both sides of the island.

- (e) In the First Schedule (No Waiting at Any Time) after item number 144 there shall be inserted:
- 144A Twyford Road

Both


From a point 39 metres south of its junction with St Catherines Road northwards to a point 34 metres north of the same junction.

- (f) In the Second Schedule (No Waiting Monday to Saturday 8.00am-6.00pm) item number 6 (relating to Romsey Close) shall be revoked.
- (g) In the Thirteenth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) after item number 11 there shall be inserted:



















Proposed waiting restrictions -Twyford Road and St Catherines Road









