- 5. Dutton Lane West From the southern boundary wall of No. 45
 Dutton Lane southwards to the northern
 boundary wall of No. 17 Dutton Lane.

- (b) In the Fourth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am- 8.00pm Monday to Saturday) item number 5 (relating to Dutton Lane) shall be revoked and replaced with:
- 5. Dutton Lane
