

THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE)
(PROHIBITION AND RESTRICTION OF WAITING)
(DISABLED PERSONS PARKING PLACES)
(AMENDMENT NO.11) ORDER 2007

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 4, 45, 46, 46A and 51 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 14 May 2007 and may be cited as the "Borough of Eastleigh (Eastleigh Town Centre) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Amendment No.11) Order 2007".

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough Of Eastleigh (Eastleigh Town Centre) (Prohibition And Restriction Of Waiting) (Disabled Persons Parking Places) Order 2004
3. The Principal Order is hereby amended as follows:
 - (a) Articles 4 (1), 4A and 19A shall be amended to include the words "and Seventeenth" after the words "Fifteenth (Part B)".
 - (b) After Article 5B there shall be inserted:

5C. Save as provided in Articles 9 and 24 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a parking attendant cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm on any day other than a Sunday on the sides of roads or in the lengths of roads specified in the Seventeenth Schedule to this Order-

 - (a) for a longer period than 1 hour; or
 - (b) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads.
 - (c) In the Fourth Schedule items number 2, 3 and 4 relating to High Street shall be deleted.

(d) After the Sixteenth Schedule (No Waiting Monday to Saturday 8.00 am- 8.00 pm) there shall be inserted:

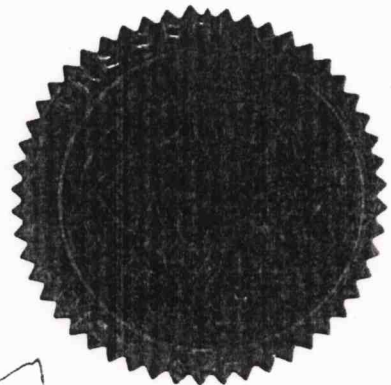
SEVENTEENTH SCHEDULE

Pay & Display Parking (1 Hour Maximum Stay No Return Within Two Hours)
Monday to Saturday 8.00 am- 6.00 pm

| Road | Side | Description | Parking Charge |
|----------------|------|---|----------------|
| 1. High Street | East | From a point 160 metres north of the junction with Wells Place northwards for a distance of 12 metres. | 60p |
| 2. High Street | West | From a point 64 metres south of the junction with Leigh Road to a point 90 metres north of the junction with Wells Place. | 60p |
| 3. High Street | West | From a point 14 metres north of the junction with Wells Place northwards for a distance of 50 metres. | 60p |
