THE BOROUGH OF EASTLEIGH (GOLDSMITH ROAD AND O'CONNELL ROAD AREA) (RESIDENTS PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (EIGHTH ZONE) (CONTROLLED ZONE) (AMENDMENT NO.2) ORDER 2007

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2, 4, 32, 35, 45, 46 and 51 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

This Order shall come into operation on 19 November 2007 and may be cited as "The Borough of Eastleigh (Goldsmith Road and O'Connell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Eighth Zone) (Controlled Zone) (Amendment No.2) Order 2007".

Prohibition and Restriction of Waiting

1. In this Order the Principal Order means Borough of Eastleigh (Goldsmith Road and O'Connell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Eighth Zone) (Controlled Zone) Order 2006

2. The Principal Order is hereby amended as follows:

(a) After Article 21 (E)(1) there shall be inserted:

*"21. (F) (1) Any person who*

*(a) is the owner of a vehicle of the following class, that is to say a passenger vehicle, a goods vehicle or a motorcycle, or*

*(b) with the permission of the owner uses a vehicle of the said class on a regular basis*

*and rents an allotment in Tennyson Road, Eastleigh but is not an entitled resident or a business permit holder may apply to the Council for the issue of one permit in respect of his or her household for the leaving in any parked space of such vehicle or vehicles and any such application shall be made on the form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied and shall include the appropriate permit charge as specified in Article 21(F) (5) to this Order.*



(2) The Council may at any time require an applicant for a permit or a permit holder to produce to an Officer of the Council such evidence in respect of an application for a permit made to them as they may reasonably require to verify any particulars or information given to them or in respect of any permit issued by them as they may reasonably require to verify the permit is valid. If such evidence in respect of an application for a permit cannot be supplied the Council shall have discretion on whether or not a permit is issued.

(3) On receipt of an application duly made under the foregoing provisions of this Article including the receipt of the appropriate permit charge the Council upon being satisfied that the applicant is either-

- (a) the owner of a vehicle of the class specified in paragraph (1) of this Article or
- (b) a person authorised by the owner of a vehicle of the said class

and rents an allotment on Tennyson Road, Eastleigh and is not entitled resident or a business permit holder may issue to the applicant one permit for the leaving during the permitted hours in any parking places of vehicles to which such permit relates by the owner of such vehicle or by any person using such vehicle with the consent of the owner other than a person to whom such vehicle has been let for hire or reward.

(5) The charge in connection with the issue of parking permit to a person who rents an allotment in Tennyson Road, Eastleigh shall be £30 for 12 months running from the annual renewal date."

(b) After Article 29 there shall be inserted:

"29A. Save as provided in Articles 30, 32, 33 and 34 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a parking attendant cause or permit any vehicle to wait during the permitted hours on the sides of roads or in the lengths of roads specified in the Eighth Schedule to this Order-

- (a) for a longer period than four hours; or
- (b) if a period of less than five hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads."

(c) In Article 30 after the words "Nothing in Articles 28 and 29" the words "and 29A" shall be inserted.

(d) In Article 32 after the words "Nothing in Article 29" the words "and 29A" shall be inserted.

(e) In Article 33 after the words "Nothing in Article 29" the words "and 29A" shall be inserted.

(f) Article 34 shall be revoked and replaced with:

*" 34. Nothing in Article 29 or 29A of this Order shall render it unlawful to permit or cause a vehicle which displays in a relevant position an entitled residents parking permit or a business parking permit to wait on the sides of roads referred to in the Fifth Schedule or Eighth Schedule of this Order."*

(g) In the First Schedule Part A Eighth Zone item "2. Cherbourg Road (from Tennyson Road to the south-eastern boundary of No.37 Cherbourg Road)" shall be revoked and replaced with:

2. Cherbourg Road (from Tennyson Road to the Access Road to the rear of Nos 237-287 Chamberlayne Road)

(h) In the First Schedule Part A Eighth Zone item "4. Derby Road (from Elm Grove to Nutbeem Road)" shall be revoked and replaced with:

4. Derby Road (from Passfield Avenue to Nutbeem Road)

(i) In the First Schedule Part B Additional Premises entitled to Permits item "24. Cherbourg Road (even Nos. 20-36)" and item "25. Passfield Avenue (Nos 153, 155 and 157)" shall be revoked and replaced with:

24. Barton Peveril College, Chestnut Avenue  
25. Passfield Avenue (odd Nos. 153 – 193)

(j) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) after item number 10 relating to Cherbourg Road there shall be inserted:

10A. Cherbourg Road	South	From a point 15 metres east of its junction with the access to the Quilley School of Engineering eastwards to a point 76 metres east of the access.

(k) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) after item number 17 relating to Derby Road there shall be inserted:

17A.	Derby Road	South	From the eastern boundary of No. 133 Derby Road eastwards to a point 15 metres west of its junction with Burns Road.

(l) In the Third Schedule (No Waiting at an time) items numbered 16 and 19 relating to Cherbourg Road shall be revoked and replaced with:

16.	Cherbourg Road	North	From a point 6.7 metres east of the western boundary of No. 50 Cherbourg Road eastwards and south-eastwards its junction with the Access Road to the rear of Nos 237-287 Chamberlayne Road.

19.	Cherbourg Road	South	From a point 18.5 metres east of the western boundary of No. 43 Cherbourg Road south-eastwards to a point 22 metres northwest of the access to the Quilley School of Engineering.

19A.	Cherbourg Road	South	From a point 91 metres east of its junction with the access to the Quilley School of Engineering eastwards to its junction with the Access Road to the rear of Nos 237-287 Chamberlayne Road.

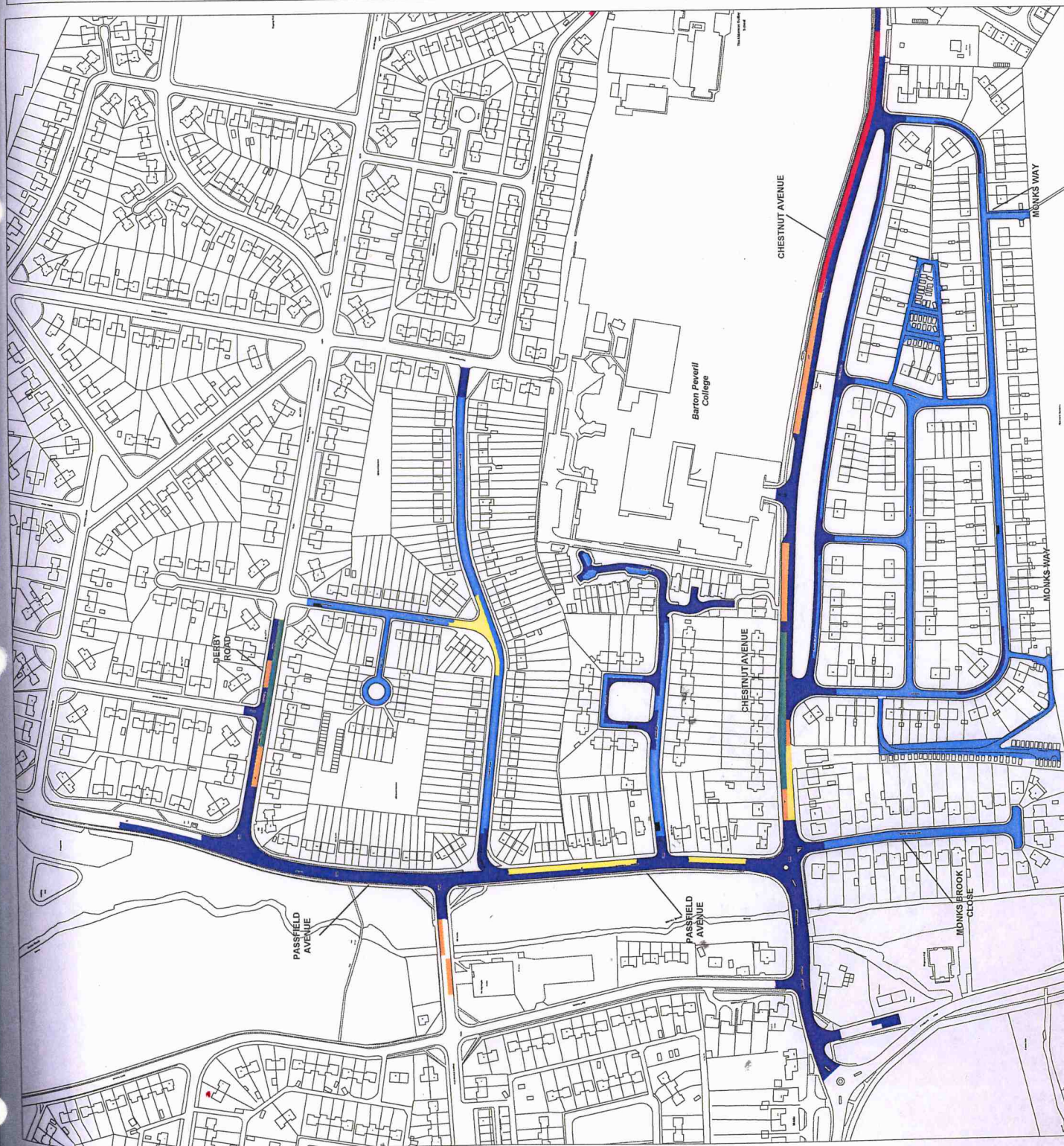
(m) In the Third Schedule (No Waiting at an time) after item number 32 relating to Derby Road shall be revoked and replaced with:

32A.	Derby Road	North	From its junction with Passfield Avenue eastwards to its junction with Elm Grove.

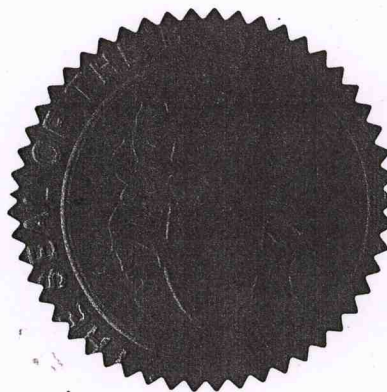
