THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE) (PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (AMENDMENT NO.13) ORDER 2007

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 19 November 2007 and may be cited as the "Borough of Eastleigh (Eastleigh Town Centre) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Amendment No.13) Order 2007".

Prohibition and Restriction of Waiting

- In this Order the Principal Order means The Borough Of Eastleigh (Eastleigh Town Centre) (Prohibition And Restriction Of Waiting) (Disabled Persons Parking Places) Order 2004
- 3. The Principal Order is hereby amended as follows:
 - (a) In the First Schedule (No Waiting at Any Time) items numbered 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 31A relating to Cherbourg Road; items numbered 32, 35, 36, 37 and 43A relating to Chestnut Avenue; items numbered 53A and 53B relating to Eastleigh College car park entrance; and item number 135 relating to Southampton Road shall be revoked.
 - (b) In the First Schedule (No Waiting at Any Time) after item number 77 relating to the link road between Stoneham Lane and M27 Junction 5

(d) In the First Schedule (No Waiting at Any Time) items numbered 156, 157 and 158 relating to Wide Lane shall be revoked and replaced with:

156. Wide Lane

Both

From a point 40 metres northeast of the Wide Lane Link north-eastwards to its junction with South Street.

(e) In the Third Schedule (No Waiting – Monday to Friday 8.00am – 6.00pm) after item number 4 relating to Maple Square the following shall be inserted:

5. Passfield Avenue East

From a point 15 metres south of its junction with Locksley Road southwards to a point 15 metres north of its junction with Cedar Road.

6. Passfield Avenue East

From a point 15 metres south of its junction with Cedar Road southwards to a point 25 metres north of its junction with Chestnut Avenue.
