### PART I- GENERAL

#### Commencement and Citation

1. This Order shall come into operation on 21 February 2008 and may be cited as the "Borough of Eastleigh (Lakeside Country Park) (Off-Street Car Park) (Amendment No.1) Order 2008".

#### Interpretation

- 2. (1) In this Order the Principle Order means the Borough of Eastleigh (Lakeside Country Park) (Off-Street Car Park) Order 2006.
- 3. The Principle Order is hereby amended as follows:
  - (a) Delete Article 21 and replace with:
  - 21. If a vehicle is left in a parking place during the charging hours for a period longer than that for which the payment was made or in contravention of any other provision of this Order a penalty charge shall be payable.
  - (b) Delete Article 23 and replace with:
  - 23. The penalty charge shall be paid in the manner specified on the penalty charge notice.
  - (c) Article 24 shall be amended to replace Article 25 with Article 22.
