Prohibition and Restriction of Waiting

- 2. In this Order the Principal Order means The Borough Of Eastleigh (Chandlers Ford and Hiltingbury) (Prohibition And Restriction Of Waiting) (Disabled Persons Parking Places) Order 2004
- 3. The Principal Order is hereby amended as follows:
 - (a) In the First Schedule (No Waiting at Any Time) item A relating to Ashdown Road shall be revoked and replaced with:

A.	Ashdown Road	Northwest	From its junction with Hiltingbury Road north eastwards to a point 20 metres north east of its junction with Richmond Close.
