The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

 This Order shall come into operation on 22 February 2010 and may be cited as "The Borough Of Eastleigh (Campbell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Sixth Zone) (Controlled Zone) (Amendment No.3) Order 2010"

Prohibition and Restriction of Waiting

- In this Order the Principal Order means The Borough Of Eastleigh (Campbell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Sixth Zone) (Controlled Zone) Order 2004
- 3. The Principal Order is hereby amended as follows:
 - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 5 (relating to Campbell Road) shall be revoked and replaced with:
- 5. Campbell Road South west From the southeastern boundary wall of No.40 Campbell Road southeastwards to a point 1 metre northwest of the southeastern boundary wall of No.62 Campbell Road.
 - (b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 8 (relating to Campbell Road) shall be revoked.
 - (c) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 9 (relating to Campbell Road) shall be revoked and replaced with:

- 9. Campbell Road Southwest From the southeastern boundary wall of No.106 Campbell Road southeastwards to the southeastern boundary wall of No.118 Campbell Road.
 - (d) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 12A (relating to Campbell Road) shall be revoked and replaced with:
- 12A. Campbell Road Northeast From a point 2 metres southeast of the southeastern boundary wall of No.19 Campbell Road southeastwards to a point 1.5 metres southeast of the southeastern boundary wall of No.21 Campbell Road.
 - (e) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 18 (relating to Campbell Road) shall be revoked and replaced with:

18. Campbell Road Northeast From the southeastern boundary wall of No.89 Campbell Road southeastwards to a point 0.5 metres southeast of the southeastern boundary wall of No.99 Campbell Road.

18A. Campbell Road Northeast Southeastern boundary wall of No.101 Campbell Road southeastwards to the southeastern boundary wall of No.105 Campbell Road.

18B. Campbell Road Northeast From a point 1.5 metres southeast of the southeastern boundary wall of No.107 Campbell Road southeastwards to a point 1.5 metres southeast of the southeastern boundary wall of No.109 Campbell Road.

(f) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 21 (relating to Campbell Road) shall be revoked and replaced with:

13. Campbell Road Northeast From a point 1.5 metres southeast of the southeastern boundary wall of No.21 Campbell Road southeastwards to the southeastern boundary wall of No.25 Campbell Road.

(i) In the Third Schedule (No Waiting at Any Time) item number 19 (relating to Campbell Road) shall be revoked and replaced with:

19. Campbell Road Northeast From a point 1.5 metres southeast of the southeastern boundary wall of No.109 Campbell Road southeastwards to the southeastern boundary wall of No.113 Campbell Road.
