THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE) (AMENDMENT NO.5) ORDER 2010

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 25 March 2010 and may be cited as "the Borough of Eastleigh (Eastleigh Town Centre) (Amendment No.5) Order 2010".

Prohibition and Restriction of Waiting

- 2. In this Order the Principal Order means The Borough Of Eastleigh (Eastleigh Town Centre) Consolidation Order 2008
- 3. The Principal Order is hereby amended as follows:
 - (a) In Article 2(1) after the definition of "hackney carriage" there shall be inserted:
 - ""heavy or large goods" includes all heavy, large or unmanageable goods that are unable to be carried more than a short distance and "delivery and collection" or "loading and unloading", in relation to heavy, large or unmanageable goods, includes checking the goods for the purpose of their delivery or collection and does not include any period prior to purchasing goods but only for the collection of pre-paid items when they are large, heavy or unmanageable;"
 - (b) In Article 2(1) the definition of "motorcycle" shall be revoked and replaced with:
 - "solo motorcycle" means a motor cycle without a side car and having two wheels:"
 - (c) All references to 'motorcycle' shall be amended to read 'solo motorcycle';
 - (d) In Articles 14 and 15 after the words 'unless loading or unloading' the following words are inserted 'of heavy or large goods';
 - (e) In Article 15 the words 'Ninth Schedule' shall be amended to read 'Tenth Schedule';
