THE BOROUGH OF EASTLEIGH (DERBY ROAD AREA) (RESIDENTS PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (THIRD ZONE) (CONTROLLED ZONE) (AMENDMENT NO.5) ORDER 2011

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

 This Order shall come into operation on 14 March 2011 and may be cited as "The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.5) Order 2011"

Prohibition and Restriction of Waiting

- 2. In this Order the Principal Order means The Borough of Eastleigh (Newtown Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (First Zone) (Controlled Zone) Order 2004
- 3. The Principal Order is hereby amended as follows:
 - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 18 (relating to Desborough Road) shall be revoked and replaced with:

18.	Desborough Road	East	From a point 6.3 metres south of the southern boundary wall of No. 220 Desborough Road southwards to the northern boundary wall of No.234 Desborough Road.
18A.	Desborough Road	East	From a point 6.5 metres south of the northern boundary wall of No.234 Desborough Road southwards to the southern boundary wall of No.258 Desborough Road.

(b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 19 (relating to Grantham Road) shall be revoked and replaced with:

19.	Grantham Road	North	From a point 30 metres west of the junction with High Street westwards for a distance of 5 metres.

43 metres west of the junction with High

- 32. Market Street West From a point 10 metres south of the junction with Grantham Road southwards to a point 4.5 metres north of the southern boundary wall of No.207 Market Street.
- 32A. Market Street West From a point 2 metres south of the southern boundary wall of No.207 Market Street southwards to a point 3 metres south of the southern boundary wall of No.247 Market Street.
 - (e) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 33 (relating to Market Street) shall be revoked and replaced with:
- 33. Market Street West From a point 3 metres north of the northern boundary wall of No. 255 Market Street southwards to a point 6.5 metres south of the southern boundary wall of No.301 Market Street.
 - (f) In the Third Schedule (No Waiting at any time) after item number 19 (relating to Derby Road) there shall be inserted:

19A. Derby Road

North

From the eastern boundary wall of No.2 Derby Road eastwards for a distance of 7.5 metres.

- (g) In the Third Schedule (No Waiting at any time) items numbered 27, 28 and 28A (relating to Desborough Road) shall be revoked and replaced with:
- 27. Desborough Northern From its western kerbline eastwards to a point 5 Road Closed metres west of the eastern kerbline. End

- 37A. Grantham Road North From a point 25.3 metres west of the junction with High Street westwards for a distance of 4.7 metres.
- 37B. Grantham Road North From a point 35 metres west of the junction with High Street westwards for a distance of 8 metres.
 - (i) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am – 8.00pm Monday to Saturday Exemption for Permit Holders – Carers Permits Three Hours) item number 4 (relating to Derby Road) shall be revoked and replaced with:
- 4. Derby Road North From a point 12 metres west of the junction with Market Street westwards for a distance of 11 metres.
 - (j) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am – 8.00pm Monday to Saturday Exemption for Permit Holders – Carers Permits Three Hours) item number 8A (relating to Desborough Road) shall be revoked.
 - (k) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am – 8.00pm Monday to Saturday Exemption for Permit Holders – Carers Permits Three Hours) item number 11 (relating to Grantham Road) shall be revoked and replaced with:
- 11. Grantham Road North From a point 10 metres west of the junction with High Street westwards for a distance of 15.3 metres.

 In the Sixth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) after item number 2A (relating to Cranbury Road) there shall be inserted:
