

THE BOROUGH OF EASTLEIGH (STANIER WAY, HEDGE END)  
EXPERIMENTAL ORDER 2011

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 27 May 2011 and may be cited as the "Borough of Eastleigh (Stanier Way, Hedge End, West End and Botley) Experimental Order 2011".

Prohibition and Restriction of Waiting

2. In this Order the Principle Order means The Borough of Eastleigh (Hedge End) Consolidation Order 2008

3. The Principle Order is hereby amended as follows:

(a) In the First Schedule (No Waiting at Any Time) after item number 198 relating to Sowden Close there shall be inserted:

| 198A. | Stanier Way | North West | From the junction with Maunsell Way in a South western direction For a distance of 18 metres. |
| 198B. | Stanier Way | South East | From its junction with Maunsell Way in a south western direction for a distance of 16 metres. |

4. The provisions of this Order may be amended or varied or suspended in accordance with the Regulations governing Experimental Orders.
