## THE BOROUGH OF EASTLEIGH (FACTORY ROAD AREA) (RESIDENTS PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (SECOND ZONE) (CONTROLLED ZONE) (AMENDMENT NO.7) ORDER 2011

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

## Commencement and Citation

1. This Order shall come into operation on 4 July 2011and may be cited as "The Borough of Eastleigh (Factory Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Second Zone) (Controlled Zone) (Amendment No.7) Order 2011"

## Prohibition and Restriction of Waiting

- 2. In this Order the Principal Order means The Borough of Eastleigh (Newtown Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (First Zone) (Controlled Zone) Order 2004
- 3. The Principal Order is hereby amended as follows:
  - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 23 (relating to Desborough Road) shall be revoked and replaced with:
- 23. Desborough Road West From the southern boundary wall of No.7 Desborough Road southwards to a point 2 metres south of the southern boundary wall of No. 55 Desborough Road.
  - (b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 33C (relating to Factory Road) shall be revoked and replaced with:
- 33C. Factory Road South From a point 22 metres west of its junction with Desborough Road westwards for a distance of 13 metres.
  - (c) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am 8.00pm Monday to

Saturday) item number 16 (relating to Desborough Road) shall be revoked;

- (d) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am 8.00pm Monday to Saturday) after item number 17 (relating to Factory Road) there shall be inserted:
- 18. Factory Road South From a point 10 metres west of its junction with Desborough Road westwards for a distance of 12 metres.
