THE BOROUGH OF EASTLEIGH (PERMIT CHARGES) ORDER 2011

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

This Order shall come into operation on 19 October 2011 and may be cited as the "Borough of Eastleigh (Permit Charges) Order 2011".

Prohibition and Restriction of Waiting

- 1. In this Order the Principal Orders mean:
 - i) The Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) Order 2004;
 - ii) The Borough of Eastleigh (Dutton Lane and Barton Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Fifth Zone) (Controlled Zone) Order 2004;
- iii) The Borough of Eastleigh (Campbell Road Area) (Residents Parking Places and Prohibition and Restriction Of Waiting) (Disabled Persons Parking Places) (Sixth Zone) (Controlled Zone) Order 2004;
- iv) The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction Of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) Order 2004;
- v) The Borough of Eastleigh (Factory Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Second Zone) (Controlled Zone) Order 2004;
- vi) The Borough of Eastleigh (Newtown Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (First Zone) (Controlled Zone) Order 2004;
- vii) Borough of Eastleigh (Brookwood Avenue Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Seventh Zone) (Controlled Zone) Order 2006;
- viii) Borough of Eastleigh (Goldsmith Road and O'Connell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Eighth Zone) (Controlled Zone) Order 2006:
- ix) The Borough of Eastleigh (Monks Way and Locksley Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Ninth Zone) Order 2007; and
- x) The Borough of Eastleigh (North End Copse Area) (Eleventh Zone) Order 2010.

The Principle Orders are hereby amended as follo
--

- (i) Article 21(A) (5) shall be revoked and replaced with:
 - (5) (i) The charge in connection with the issue of an entitled residents parking permit shall be as set out in the table below and shall be valid for the period as set out below:

Appropriate Permit Charge Duration

First Residents Permit- £30.00 12 months running Second Residents Permit- £60.00 from the annual renewal date

(5) (ii) Any existing holder of a first free residents permit, applying for renewal of that permit will be exempt from any charge for a first residents permit as shown in Article 21(A)(5)(i) of this Order. In this Section 'existing holder of a first free residents permit' means any resident issued with a free first residents permit in the year preceding the year of renewal and 'renewal' means the renewal of a residents permit issued to the same resident at the same address as the previous year.
