# THE BOROUGH OF EASTLEIGH (HEDGE END, WEST END AND BOTLEY) (AMENDMENT NO.5) ORDER 2012

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

## Commencement and Citation

1. This Order shall come into operation on 16 December 2011 and may be cited as the "Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No.5) Order 2012.

### Prohibition and Restriction of Waiting

- 2. In this Order the Principle Order means The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2008
- 3. The Principal Order is hereby amended as follows:
  - (a) After Article 26(f) there shall be inserted:
    - (g) between the hours of 8.00am and 9.00am and 2.30pm and 4.00pm on any day other than a Saturday or Sunday in the roads, on the sides of roads or in any lengths of roads specified in the Twentieth Schedule to this Order;
  - (b) In the First Schedule (No Waiting at Any Time) after item number 1 (relating to Alexandra Way) there shall be inserted:

1A.	Allen Road	North	From a point 37 meters east of its junction with Wildern Lane in an eastern and south-eastern direction for a distance of 39 metres.
1B.	Allen Road	South	From its junction with Wildern Lane in an eastern direction for a distance of 47 metres.
1C.	Allen Road	North-west	From a point opposite a point 17 metres south-west of its junction with Lewry Close in a north-eastern direction for a distance of 37 metres.



1D.	Allen Road	South-east	From its junction with Lewry Close in a south-western direction for a distance of 17 metres.			
1E.	Allen Road	South-east	From its junction with Lewry Close in a north-eastern direction for a distance of 16 metres			
1F.	Allen Road	North and east side	From a point 56 meters north-east of its junction with Raeburn Drive following the outer kerb line in an eastern and southern direction for a distance of 70 metres.			
1G.	Allen Road	South and west side	From the north-east boundary of 34 Allen Road following the inner kerb line in an eastern and southern direction for a distance of 62 metres.








Allen Road and Raeburn Drive - Waiting Restrictions
