Commencement and Citation

1. This Order shall come into operation on 15 March 2012 and may be cited as the "Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No.7) Order 2012".

- 2. In this Order the Principal Order means The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2008
- 3. The Principal Order is hereby amended as follows:
