

THE BOROUGH OF EASTLEIGH (BURSLEDON, HAMBLE-LE-RICE AND
HOUND) (AMENDMENT NO.1) ORDER 2012

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 17 September 2012 and may be cited as the "Borough of Eastleigh (Bursledon, Hamble-le-Rice and Hound) (Amendment No.1) Order 2012".

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Bursledon, Hamble-le-Rice and Hound) Consolidation Order 2012.

3. The Principal Order is hereby amended as follows:

- (a) In the Seventeenth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) after item number 2 (relating to Boundary Road) there shall be inserted:

- (b) In the Seventeenth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) items numbered 4, 5 and 8 (relating to Cliffe Avenue and Kingfisher Close) shall be revoked.

- (c) In the Seventeenth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) after item number 9 (relating to Long Lane) there shall be inserted:

(d) In the Seventeenth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) items numbered 10, 13, 14 and 16 (relating to Satchell Lane, Victoria Road and Windmill Lane) shall be revoked.
