# THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE) (AMENDMENT NO.13) ORDER 2012

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

#### Commencement and Citation

 This Order shall come into operation on 12 November 2012 and may be cited as the "Borough of Eastleigh (Eastleigh Town Centre) (Amendment No.13) Order 2012".

#### Prohibition and Restriction of Waiting

- In this Order the Principal Order means The Borough of Eastleigh (Eastleigh Town Centre) Consolidation Order 2008.
- 3. The Principal Order is hereby amended as follows:
  - (a) In Article 3 after (f) the following shall be inserted:
    - (g) between the hours of 8.00am and 9.30am and 4.30pm and 6.00pm on any day other than a Sunday in the roads, on the sides of roads or in any lengths of roads specified in the Twenty Third Schedule to this Order;
  - (b) After Article 9A there shall be inserted:
- 9B. Save as provided in Articles 11 and 29 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a civil enforcement officer cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm on any day other than a Sunday on the sides of roads or in the lengths of roads specified in the Twenty Fourth Schedule to this Order-
  - (a) for a longer period than 2 hours; or
  - (b) if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads.
  - (c) In Article-7 after the words 'Fourteenth (Parts D & E)' there shall be inserted the words 'and Twenty Fourth';

- (d) In Article 11 after the words 'and 9' there shall be inserted 'and 8A, 9A, 9B';
- (e) In Article 29 after the number '9A' there shall be inserted the number '9B':
- (f) In the First Schedule (No Waiting At Any Time) items numbered 28F and 28H (relating to Falkland Road) shall be revoked and replaced with:
