

THE BOROUGH OF EASTLEIGH (HEDGE END, WEST END AND BOTLEY)
(AMENDMENT NO.9) ORDER 2012

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 26 October 2012 and may be cited as the "Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No.9) Order 2012".

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2008

3. The Principal Order is hereby amended as follows:

(a) In Article 26 after (g) there shall be inserted:

(h) between the hours of 8.00am and 9.00am and 3.00pm and 4.00pm on any day other than a Saturday or Sunday in the roads, on the sides of roads or in any lengths of roads specified in the Twenty First Schedule to this Order;

(b) In the First Schedule (No Waiting at Any Time) after item number 8 relating to Beacon Road there shall be inserted:

- 10iii. Beech Road Both From a point 10 metres west of its junction with Birch Road in an easterly direction to a point 10 metres east of its junction with Birch Road.

(d) In the First Schedule (No Waiting at Any Time) item numbered 10B relating to Berrywood Gardens shall be revoked and replaced with:

- 10B. Berrywood Gardens East From its junction with Turnpike Way in a south-westerly direction for a distance of 83 metres.
- 10C. Berrywood Gardens North-west From a point 1 metres south-west of the western property boundary of 14 Berrywood Gardens southwestwards for a distance of 95 metres.
- 10D. Birch Road East From its junction with Lower Northam Road in a northerly direction to a point 15 metres north of its junction with Beech Road.
- 10E. Birch Road East From a point 7 metres south of the southern property boundary of 12 Birch Road in a southerly direction for a distance of 7 metres.
- 10F. Birch Road West From its junction with Lower Northam Road in a northerly direction to a point 11 metres north of its junction with Longclose Road.

(e) In the First Schedule (No Waiting at Any Time) items numbered 12 and 13 relating to Botley Road, Hedge End shall be revoked and replaced with:

12. Botley Road, Hedge End Both From its junction with Tollbar Way in an easterly direction to its junction with Charles Watts Way.

(f) In the First Schedule (No Waiting at Any Time) after item number 17 relating to Botley Road Service Road there shall be inserted:

- 17A. Broad Oak North From its junction with Woodhouse Lane in an easterly direction to the western boundary of Montague House.
- 17B. Broad Oak South From its junction with Woodhouse Lane in an easterly direction to the western boundary of Glendover Cottage.

(g) In the First Schedule (No Waiting at Any Time) items numbered 30 and 31 relating to Chapel Drove shall be revoked and replaced with:

30. Chapel Drove East From its junction with St Johns Road in a north easterly direction for a distance of 27 metres.

31. Chapel Drove West From its junction with St John's Road in a northerly direction to a point 30 metres north of its junction with Granada Road.

(h) In the First Schedule (No Waiting at Any Time) item number 53 relating to Crabwood Drive shall be revoked and replaced with:

53. Crabwood Drive West From its junction with High Street Service Road southwards for its entire length.

(i) In the First Schedule (No Waiting at Any Time) after item number 57 relating to Eastern Road there shall be inserted:

57A. Eastern Road Both From its junction with Western Road in a south-easterly direction to the south-eastern boundary of No.11.

(j) In the First Schedule (No Waiting at Any Time) after item number 65 relating to Freegrounds Avenue car park access road there shall be inserted:

65A. Freegrounds Road North-east From a point 15 metres north-west of its junction with Linden Gardens in a south-easterly direction to a point 15 metres south-east of its junction with Linden Gardens.

65B. Freegrounds Road South-west From a point 15 metres north-west of its junction with Lower St Helens Road in a south-easterly direction to a point 15 metres south-east of its junction with Lower St Helens Road.

(k) In the First Schedule (No Waiting at Any Time) item number 73 relating to Granada Road shall be revoked and replaced with:

73. Granada Road South-east From its junction with Chapel Drove in a south-westerly direction for a distance of 104 metres.

(l) In the First Schedule (No Waiting at Any Time) after item number 79 relating to High Street, Botley there shall be inserted:

79A. High Street, Botley North From a point 15 metres east of its junction with Holmesland Lane in a westerly direction to a point 15 metres west of its junction with Holmesland Lane.

(m) In the First Schedule (No Waiting at Any Time) item number 94 relating to High Street, West End shall be revoked and replaced with:

94. High Street, West End North From a point 63 metres west of its junction with Chapel Road to a point 25 metres east of that junction.

(n) In the First Schedule (No Waiting at Any Time) item number 100 relating to Hobb Lane shall be revoked and replaced with:

100. Hobb Lane West From a point 54 metres north of its junction with Mapleton Road to a point 19.5 metres south of its junction with Mapleton Road.

(o) In the First Schedule (No Waiting at Any Time) after item number 101 relating to Hobb Lane there shall be inserted:

101A. Holmesland Drive North From its junction with Holmesland Lane eastwards for a distance of 12 metres.

101B. Holmesland Drive South From its junction with Holmesland Lane eastwards for a distance of 15 metres.

101C. Holmesland Lane Both From its junction with High Street in a northerly direction for a distance of 15 metres.

101D. Holmesland Lane East From a point 50 metres north of its junction with High Street in a northerly direction for a distance of 12 metres.

101E. Holmesland Lane East From a point 15 metres north of its junction with Holmesland Drive in a southerly direction to a point 15 metres south of its junction with Holmesland Drive.

(p) In the First Schedule (No Waiting at Any Time) after item number 105ii relating to Itchen Valley Country Park Access Road there shall be inserted:

105iii Jenkyns Close Both From its junction with High Street in a northerly direction for a distance of 15 metres.
