

THE BOROUGH OF EASTLEIGH (HEDGE END, WEST END AND BOTLEY)  
(AMENDMENT NO.10) ORDER 2013

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 7 January 2013 and may be cited as the "Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No.10) Order 2013".

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2008
3. The Principal Order is hereby amended as follows:

(a) In Article 26 after (g) there shall be inserted:

(h) between the hours of 10.00am and 11.00am and 2.00pm and 3.00pm on any day other than a Saturday or Sunday in the roads, on the sides of roads or in any lengths of roads specified in the Twenty First Schedule to this Order;

(b) After Article 29 there shall be inserted:

29A. Save as provided in Articles 33 and 35 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a Civil enforcement officer cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm on any day other than a Sunday on the sides of roads or in the lengths of roads specified in the Twenty Second Schedule to this Order-

- i. for a longer period than 2 hours; or
- ii. if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads.

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Hedge End, West End and Botley) Consolidation Order 2008

3. The Principal Order is hereby amended as follows:

(a) in Article 28 after (g) there shall be inserted:

(h) between the hours of 10.00am and 11.00am and 2.00pm and 3.00pm on any day other than a Saturday or Sunday in the roads on the sides of roads or in any lengths of roads specified in the Twenty First Schedule to this Order;

(b) After Article 29 there shall be inserted:

29A. Save as provided in Articles 33 and 35 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a Civil enforcement officer cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm on any day other than a Sunday on the sides of roads or in the lengths of roads specified in the Twenty Second Schedule to this Order:-

- i. for a longer period than 2 hours; or
- ii. if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads.



(c) In the First Schedule (No Waiting at Any Time) after item number 126 relating to Mapleton Road there shall be inserted:

126A.	Marls Road	West	From its junction with Marvin Way southwards for a distance of 15 metres.
126B	Marls Road	Both	From its junction with Marvin Way northwards for a distance of 3 metres
126C.	Marvin Way	South	From its junction with Marls Road eastwards for a distance of 15 metres.
126D.	Marvin Way	North	From the south-eastern corner of the turning head opposite number 6 Marvin Way eastwards to the junction of Marvin Way and Marls Road.

(d) In the First Schedule (No Waiting at Any Time) item number 216 relating to Upper Northam Drive shall be revoked and replaced with:

216.	Upper Northam Drive	North-east	From its junction with Comines Way in a south and south-easterly direction for a distance of 100 metres.
216A.	Upper Northam Drive	Both	From a point 15 metres north-west of its junction with West Road to a point 15 metres south-east of its junction with West Road.
216B.	Upper Northam Drive	South-west	From a point opposite a point 265 metres south-east of its junction with West Road south-eastwards for a distance of 30 metres.
216C.	Upper Northam Drive	North-east	From a point 87 metres south-east of its junction with West Road south-eastwards to a point 295 metres south-east of its junction with West Road.

(e) In the Eighteenth Schedule (No Waiting 2.00pm to 3.00pm Monday to Friday) after item number 1 relating to Old Shamblehurst Lane there shall be inserted:

2.	Upper Northam Drive	South-west	From a point opposite a point 117 metres south-east of its junction with West Road, south eastwards for a distance of 25 metres.
3.	Upper Northam Drive	South-west	From a point opposite a point 172 metres south-east of its junction with West Road, south eastwards for a distance of 80 metres.

(f) After the Twentieth Schedule there shall be inserted:

(c) in the First Schedule (No Waiting at Any Time) after item number 126 relating to Mapleton Road there shall be inserted:

126A	Maha Road	West	From its junction with Marvin Way southwards for a distance of 15 metres.
126B	Maha Road	Both	From its junction with Marvin Way northwards for a distance of 3 metres.
126C	Marvin Way	South	From its junction with Maha Road eastwards for a distance of 15 metres.
126D	Marvin Way	North	From the south-eastern corner of the turning head opposite number 8 Marvin Way eastwards to the junction of Marvin Way and Maha Road.

(d) in the First Schedule (No Waiting at Any Time) item number 216 relating to Upper Norham Drive shall be revoked and replaced with:

216	Upper Norham Drive	North-east	From its junction with Cornes Way in a south and south-easterly direction for a distance of 100 metres.
216A	Upper Norham Drive	Both	From a point 15 metres north-west of its junction with West Road to a point 15 metres south-east of its junction with West Road.
216B	Upper Norham Drive	South-west	From a point opposite a point 265 metres south-east of its junction with West Road south-eastwards for a distance of 30 metres.
216C	Upper Norham Drive	North-east	From a point 87 metres south-east of its junction with West Road south-eastwards to a point 265 metres south-east of its junction with West Road.

(e) in the Eighteenth Schedule (No Waiting 2.00pm to 3.00pm Monday to Friday) after item number 1 relating to Old Sharncliffe Lane there shall be inserted:

2.	Upper Norham Drive	South-west	From a point opposite a point 117 metres south-east of its junction with West Road, south-eastwards for a distance of 25 metres.
3.	Upper Norham Drive	South-west	From a point opposite a point 172 metres south-east of its junction with West Road, south-eastwards for a distance of 60 metres.

(f) After the Twentieth Schedule there shall be inserted:

2.	Upper Northam Drive	South-west	From a point opposite a point 15 metres south-east of its junction with West Road in a south-easterly direction to a point opposite a point 87 metres south-east of its junction with West Road.
3.	Upper Northam Drive	South-west	From a point 295 metres south-east of its junction with West Road in a southerly direction for a distance of 122 metres.
4.	Upper Northam Drive	North-east	From a point 295 metres south-east of its junction with West Road in a southerly direction for a distance of 97 metres.



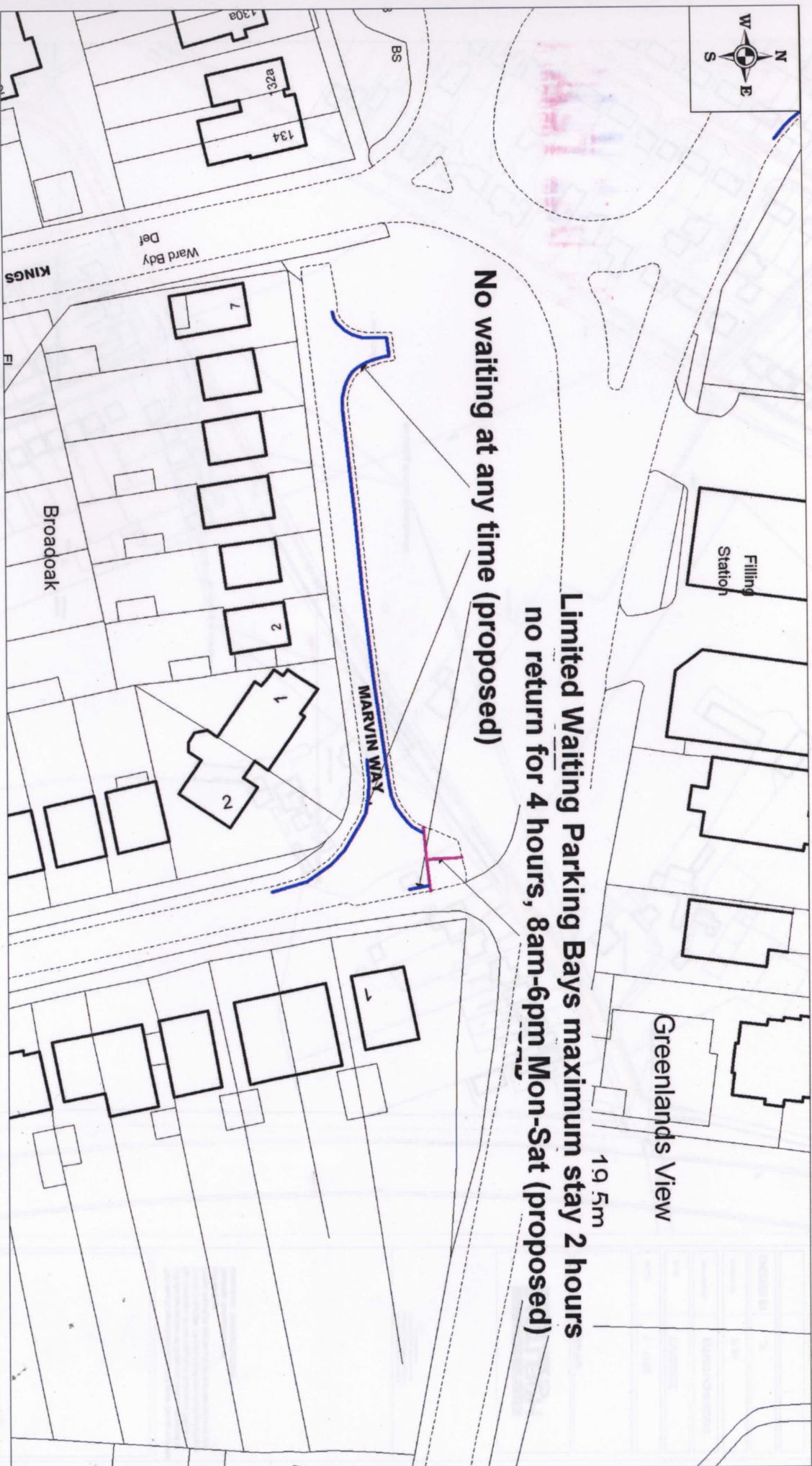
