# THE BOROUGH OF EASTLEIGH (BISHOPSTOKE, FAIR OAK AND HORTON HEATH) (PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (AMENDMENT NO.5) ORDER 2013

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

#### Commencement and Citation

 This Order shall come into operation on 27 March 2013 and may be cited as the "Borough of Eastleigh (Bishopstoke, Fair Oak and Horton Heath) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Amendment No.5) Order 2013".

#### Prohibition and Restriction of Waiting

- In this Order the Principal Order means The Borough of Eastleigh (Bishopstoke, Fair Oak and Horton Heath) (Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) Order 2004
- 3. The Principal Order is hereby amended as follows:
  - (a) In Article 20 after paragraph (c) there shall be inserted:
    - (d) Between the hours of 8.00am and 9.00am and 3.00pm and 4.00pm on any day other than a Saturday or Sunday between 1 September and 31 July inclusive in the roads, on the sides of roads, or in any lengths of roads specified in the Eighth Schedule to this Order;
  - (b) In the First Schedule (No Waiting at Any Time) after item A relating to Abbotsbury Road there shall be inserted:
- B. Ascot Road Both From its junction with Knowle Lane in a south easterly direction for a distance of 15 metres.
  - (c) In the First Schedule (No Waiting at Any Time) after item 1 relating to Blackberry Drive there shall be inserted:
- 1A. Bodmin Road North From a point 6 metres east of the eastern property boundary of 10 Bodmin Road in a south-easterly direction for a distance of 13 metres.
