The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

 This Order shall come into operation on 1 July 2013 and may be cited as "The Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) (Amendment No.8) Order 2013"

Prohibition and Restriction of Waiting

- In this Order the Principal Order means The Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) Order 2004
- 3. The Principal Order is hereby amended as follows:
 - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 8, 8A and 8B (relating to Cheriton Road) shall be revoked and replaced with:
- 8. Cheriton Road North- From the northeastern property wall of No.18 west Cheriton Road south-westwards to the south-western limit of the adopted highway.
 - (b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 10 and 10A (relating to Chestnut Avenue) shall be revoked and replaced with:
- 10. Chestnut Avenue North-east From a point 6.6 metres northwest of the southeastern boundary wall of No. 18
 Chestnut Avenue northwestwards to the southeastern boundary wall of No. 34
 Chestnut Avenue.

- (c) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 21 and 22 (relating to Doncaster Road) shall be revoked and replaced with:
- 21. Doncaster Road Southeast From the southern boundary wall of No.1
 Doncaster Road southwestwards to a point 5
 metres southwest of the northeastern boundary
 wall of No.45 Doncaster Road.
- 22. Doncaster Road Southeast From a point 18.2 metres south-west of the northeastern boundary wall of No.45 Doncaster Road south-westwards to the south-western boundary wall of No.77 Doncaster Road.
 - (d) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 24 (relating to High Street) shall be revoked and replaced with:
- 24. High Street

 Southeast

 From a point 1 metre north-east of the south-western boundary wall of No.296 High Street south-westwards to a point 6.6 metres north-east of the south-western boundary wall of No.316 High Street.
- 24A. High Street

 Southeast From the south-western boundary of No.316 High Street south-westwards to a point 1 metre northeast of the south-western boundary wall of No.296 High Street.
 - (e) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 26 and 27 (relating to Mansbridge Road) shall be revoked and replaced with:
- 26. Mansbridge Road Northeast From a point 28 metres southeast of its junction with Chestnut Avenue southeastwards for a distance of 17 metres.
- 26A. Mansbridge Road Northeast From a point 51.6 metres southwest of its junction with Chestnut Avenue southeastwards to a point 3.2 metres north-west of the western boundary of No.37 Chestnut Avenue.
- 27. Mansbridge Road Northeast From the eastern boundary of No. 37 Chestnut Avenue southeastwards for a distance of 5 metres.
 - (f) In the Seventh Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) items numbered 1A, 1B and 1C (relating to Cheriton Road and Chestnut Avenue) shall be revoked and replaced with:
