The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 13 May 2013 and may be cited as "The Borough of Eastleigh (Goldsmith Road and O'Connell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Eighth Zone) (Controlled Zone) (Amendment No.6) Order 2013"

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Goldsmith Road and O'Connell Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Eighth Zone) (Controlled Zone) Order 2006

3. The Principal Order is hereby amended as follows:

(a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 9, 10 and 10B (relating to Cherbourg Road) shall be revoked and replaced with:

(b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 28 and 29 (relating to Greenwood Close) shall be revoked and replaced with:

(c) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 58 and 58A (relating to Tennyson Road) shall be revoked and replaced with:

58. Tennyson Road East From a point 48 metres south of its junction with Derby Road southwards to a point 15 metres north of its junction with Cherbourg Road.

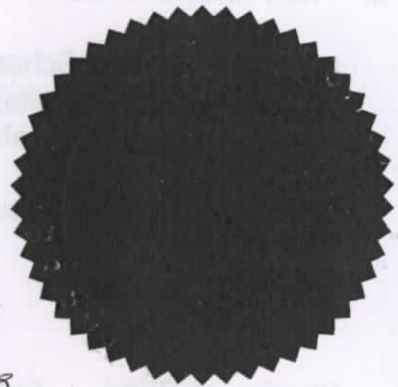



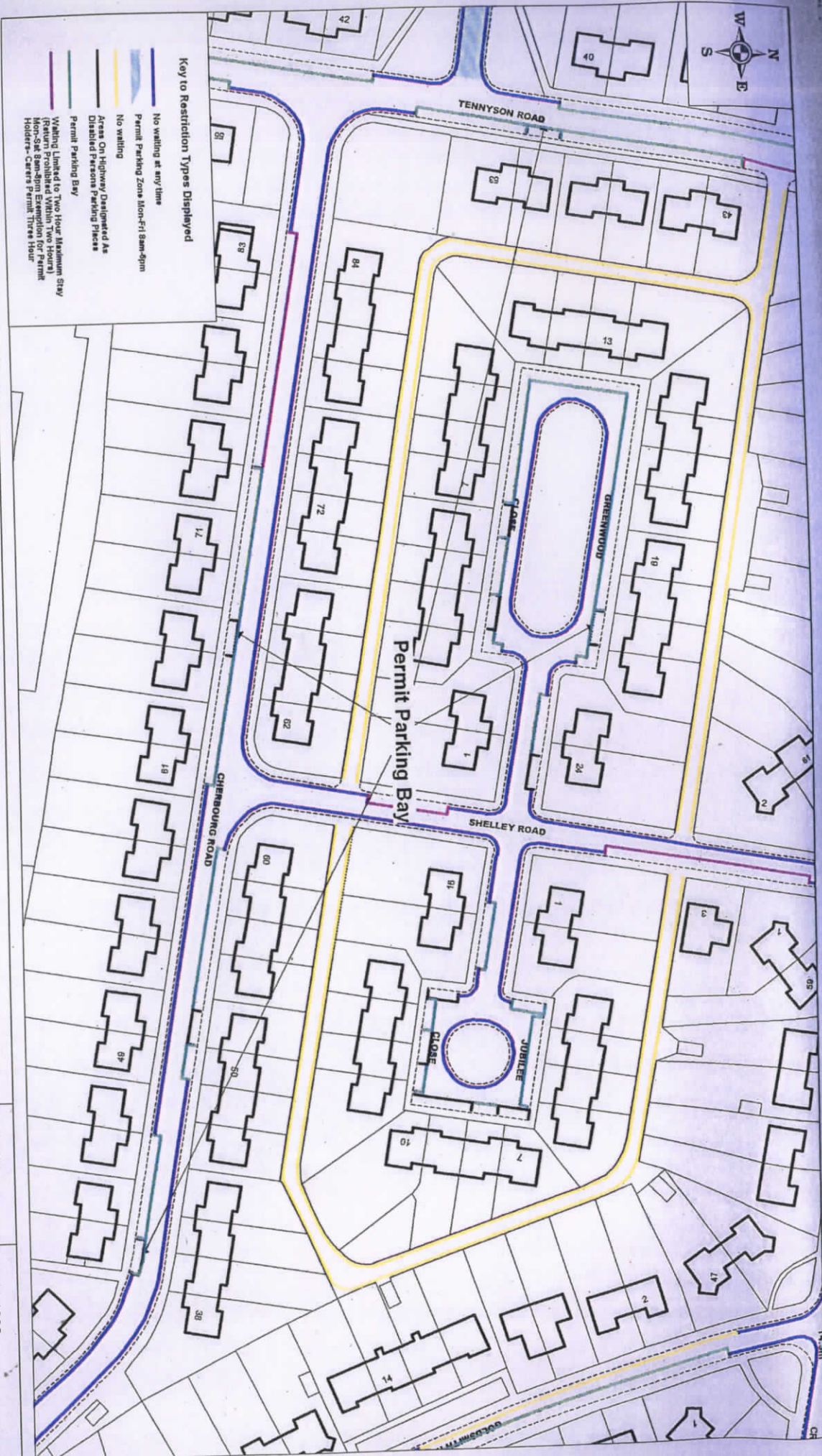
