Commencement and Citation

 This Order shall come into operation on 13 May 2013 and may be cited as "The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.8) Order 2013"

Prohibition and Restriction of Waiting

- In this Order the Principal Order means The Borough of Eastleigh (Newtown Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (First Zone) (Controlled Zone) Order 2004
- 3. The Principal Order is hereby amended as follows:
 - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 2 and 3 (relating to Chamberlayne Road) shall be revoked and replaced with:
- 2. Chamberlayne Road

West

From a point 8.6 metres south of the northern boundary wall of no. 239 Chamberlayne Road southwards to a point 2 metres south of the southern boundary wall of No.283 Chamberlayne Road.

- (b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 7 and 7A (relating to Cranbury Road) shall be revoked and replaced with:
- 7. Cranbury Road West

From the northern boundary of No. 217 Cranbury Road southwards to a point 2 metres south of the southern boundary of No. 245 Cranbury Road.

(c) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 19A (relating to Grantham Road) shall be revoked and replaced with:

19A. Grantham Road North From a point 26 metres east of the junction with Desborough Road to a point 6.6 metres west of the eastern boundary wall of No. 16 Grantham Road.

19B. Grantham Road North From the eastern boundary of No. 16 Grantham Road eastwards to a point 43 metres west of the junction with High Street.




