# THE BOROUGH OF EASTLEIGH (DERBY ROAD AREA) (RESIDENTS PARKING PLACES AND PROHIBITION AND RESTRICTION OF WAITING) (DISABLED PERSONS PARKING PLACES) (THIRD ZONE) (CONTROLLED ZONE) (AMENDMENT NO.9) ORDER 2013

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

#### Commencement and Citation

 This Order shall come into operation on 16 December 2013 and may be cited as "The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.9) Order 2013"

### Prohibition and Restriction of Waiting

2. In the following Orders:

(a) The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.8) Order 2013;

(b) The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.7) Order 2011;

(c) The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.6) Order 2011; and

(d) The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) (Amendment No.5) Order 2011:

Article 2, in each case, shall be amended to read:

- In this Order the Principal Order means The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) Order 2004
- In this Order the Principal Order means The Borough of Eastleigh (Derby Road Area) (Residents Parking Places and Prohibition and Restriction of

Waiting) (Disabled Persons Parking Places) (Third Zone) (Controlled Zone) Order 2004

- 4. The Principal Order is hereby amended as follows:
  - (a) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) item number 17 (relating to Desborough Road shall be revoked and replaced with:
- 17. Desborough Road

East

From a point 13 metres south of the northern closed end southwards for a distance of 13 metres.

- (b) In the Second Schedule (Areas on Highway Designated as Parking Places with Permits) items numbered 32 and 32A (relating to Market Street) shall be revoked and replaced with:
- 32. Market Street

West

From a point 10 metres south of the junction with Grantham Road southwards to a point 3 metres south of the southern boundary wall of No.247 Market Street...

- (c) In the Third Schedule (No Waiting at any time) item number 33 (relating to Desborough Road) shall be revoked and replaced with:
- 33. Desborough Road

East

From a point 26 metres south of the northern closed end southwards to a point opposite the southern boundary wall of No.235 Desborough Road.

- (d) In the Fifth Schedule (Waiting Limited to Two Hours Maximum Stay [Return Prohibited Within Two Hours] 8.00am – 8.00pm Monday to Saturday Exemption for Permit Holders – Carers Permits Three Hours) after item number 7 (relating to Desborough Road) there shall be inserted:
- 7A. Desborough Road

East

From the northern closed end southwards for a distance of 13 metres.

(e) In the Sixth Schedule (Areas on the Highway Designated as Disabled Persons Parking Places) item number 2D (relating to Market Street) shall be revoked. Dated this 4th day of December 2013
