The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

 This Order shall come into operation on 9 May 2014 and may be cited as "The Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) (Amendment No.9) Order 2014"

Prohibition and Restriction of Waiting

- In this Order the Principal Order means The Borough of Eastleigh (Arnold Road Area) (Residents Parking Places and Prohibition and Restriction of Waiting) (Disabled Persons Parking Places) (Fourth Zone) (Controlled Zone) Order 2007
- 3. The Principal Order is hereby amended as follows:

In Borough of Eastleigh (Arnold Road Area) (Fourth Zone) (Controlled Zone) Consolidation Order 2007 amends Article 22 and add in Article 22A as follows:

- 22. Save as provided in Article 22A to this Order, an entitled resident will not be eligible to apply for an entitled residents permit, a business permit or visitors permit under Article 21 of this Order where there has been a development to the property after the coming into effect of this Order.
- 22A. Nothing in Article 22 of this Order shall prevent an entitled resident from applying for an entitled resident's permit, business permit or a visitor's permit if that entitled resident's usual place of abode is at premises within the boundary marked in red (excluding areas hatched in green) on plan appended to this Order.

- (h) In the Seventh Schedule (Areas On Highway Designated As Disabled Persons Parking Places) item number 1(relating to Arnold Road) and items numbered 9, 10 and 11(relating to Tichborne Road shall be revoked.
