SURREY COUNTY COUNCIL ("the Council") in exercise of their powers under Sections 1(1) and 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Commencement and citation

- 1 THIS Order may be cited as "The Surrey County Council (Various Roads in Elmbridge) (Prohibition of Stopping Outside Schools) (No.1) Order 2014 (Amendment No.3) Order 2017" and shall come into force on 15th May 2017

Interpretation

- 2 (1) In this Order the expression "the Order of 2014" means The Surrey County Council (Various Roads in Elmbridge) (Prohibition of Stopping Outside Schools) (No.1) Order 2014
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2014 shall have the same meaning as in that Order

Amendment of the Order of 2014

- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2014 shall have effect as though –
 - (a) for the First Schedule to the Order of 2014 there was substituted the First Schedule set out in The First Schedule to this Order

(b) for the Third Schedule to the Order of 2014 there was substituted the Third Schedule set out in The Second Schedule to this Order

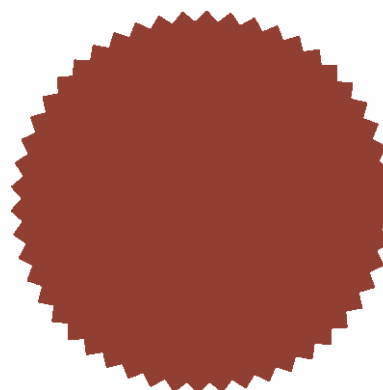
