SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

#### Citation and commencement

THIS Order may be cited as "The Surrey County Council Tilt Road, Cobham Controlled Parking Zone in the Borough of Elmbridge (Consolidation of Waiting Restrictions and Residents Only On-Street Parking Places) Order 2014 (Amendment No.4) Order 2017" and shall come into force on 15th May 2017

#### Interpretation

- 2 (1) In this Order the expression "the Order of 2014" means The Surrey County Council Tilt Road, Cobham Controlled Parking Zone in the Borough of Elmbridge (Consolidation of Waiting Restrictions and Residents Only On-Street Parking Places) Order 2014
  - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
  - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
  - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2014 shall have the same meaning as in that Order

#### Amendment of the Order of 2014

WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2014 shall have effect as though for the Second Schedule to the Order of 2014 there was substituted the Second Schedule set out in The Schedule to this Order


