

EPPING FOREST DISTRICT OFF AND ON STREET PARKING PLACES

NOTICE OF VARIATION OF CHARGES UNDER SECTIONS 35C AND 46A OF THE ROAD TRAFFIC REGULATION ACT 1984 (AS AMENDED)

NOTICE IS HEREBY GIVEN that the Epping Forest District Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Essex County Council in exercise of the powers of the said County Council, under Sections 35C (on street charges) and 45, 46 and 46(A) (Off street charges) of the Road Traffic Regulation Act 1984. intend to vary charges for its off street and on street parking places made under the following orders:

- (1) Epping Forest District Council Epping Forest District (On – Street Parking) Order 2002; and
- (2) Epping Forest District Council Epping Forest District (Off – Street Parking) Order 2003.
