

THE ESSEX COUNTY COUNCIL (EPPING FOREST DISTRICT)
(PERMITTED PARKING AREA AND SPECIAL PARKING AREA)
(AMENDMENT NO.1) ORDER 2008


Essex County Council (hereinafter referred to as 'the Council') in exercise of its powers under sections 1-4, 32, 35, 45, 46, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ('the Act'), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as The Essex County Council (Epping Forest District) (Permitted Parking Area And Special Parking Area) (Amendment No.1) Order 2008 and may be construed as one with the Essex County Council (Epping Forest District) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008 (hereinafter referred to as 'the 2008 Order'), and additional restrictions detailed within this Order are subject to the same provisions applying to the relevant Schedules of the 2008 Order.
2. The prohibitions and restrictions detailed in Schedules 1 to 3 to this Order are hereby introduced into the appropriate Schedules to the 2008 Order.
3. The prohibitions and restrictions detailed in Schedule 4 to this Order are hereby revoked from the appropriate Schedules to the 2008 Order.
4. This Order shall come into operation on 1 August 2008.

SCHEDULE 1 [additions to Schedule 53 to the 2008 Order]

Disabled Parking Bays

Amesbury, Waltham Abbey

Southwest side; from the north-western flank wall of No.46 for a distance of 5 metres in a north-westerly direction.

Audley Gardens, Loughton

Southeast side; from the common boundary of Nos. 40/42 for a distance of 5.5 metres in a south-westerly direction

Barrington Green, Loughton

East side; from the common boundary of Nos. 54/56 for a distance of 5.5 metres in a northerly direction.

Barrington Road, Loughton

Southwest side; from the north-western flank wall of No. 76 Barrington Green for a distance of 5.5 metres in a south-easterly direction.

Bushfields, Loughton

Northwest side; from a point 10 metres northeast of its junction with Alderton Hall Lane for a distance of 5.5 metres in a north-easterly direction.

Chandler Road, Loughton

- (i) North-west side; from the south-western flank wall of No.24 for a distance of 5.5 metres in a south-westerly direction.
- (ii) South side; from a point 6.5 metres west of the party wall of Nos. 21-27/29-35 for a distance of 5.5 metres in a westerly direction.

Copperfield, Chigwell

West side; from a point 1 metre south of the southern flank wall of No. 223 for a distance of 5.5 metres in a northerly direction.

Danbury Road, Loughton

Southeast side; from a point 1 metre northeast of the south-western flank wall of Nos. 22/24 for a distance of 5.5 metres in a north-easterly direction.

Deepdene Road, Loughton

West side; from the northern flank wall of No. 56 Border's Lane for a distance of 5.5 metres in a southerly direction.

Garnon Mead, Epping

West side; from a point 0.9 metres south of the northern flank wall of No. 4 for a distance of 5 metres in a southerly direction.

Goldingham Avenue, Loughton

Northwest side; from the north-eastern flank wall of No. 15 for a distance of 5.5 metres in a south-westerly direction.

Grosvenor Drive, Loughton

West side; from the common boundary of Nos. 29/31 for a distance of 5.5 metres in a northerly direction.

Grove Court, Waltham Abbey

Southeast side; from the southwest corner of the turning head for a distance of 5.5 metres in a north-easterly direction.

Hainault Grove, Chigwell

South side; from a point 10 metres east of the eastern kerb line of Hainault Road for a distance of 5.5 metres in an easterly direction.

Hanson Drive, Loughton

Northeast side; from the common boundary of Nos. 17/19 for a distance of 5.5 metres in a north-westerly direction.

Hemnall Street, Epping

Northwest side; from a point 2.2 metres southwest of the north-eastern flank wall of No. 90a for a distance of 5.5 metres in a north-easterly direction.

Hyde Mead, Nazeing

North side; from the eastern flank wall of No. 31 for a distance of 5.5 metres in a westerly direction.

Madells, Epping

West side; from a point 14.6 metres south of the southern boundary of No. 46 for a distance of 5.5 metres in a southerly direction.

Nazeingbury Parade, Nazeing

North side; from the common boundary of Nos. 8/10 for a distance of 10.2 metres in an easterly direction.

Paley Gardens, Loughton

- (i) North side; from a point 1.6 metres east of the common boundary of Nos. 14/16 for a distance of 5.5 metres in a westerly direction.
- (ii) Southwest side; from a point 12.2 metres southeast of the north-western flank wall of No. 33 to 39 for a distance of 5.5 metres in a north-westerly direction.

Park Fields, Roydon

South side; from the common boundary of Nos. 94/96 for a distance of 5.5 metres in a westerly direction.

Prescott Green, Loughton

Northeast side; from a point 0.5 metres southeast of the south-eastern flank wall No. 2 Prescott Green for a distance of 5 metres in a north-westerly direction.

Pyrles Lane, Loughton

East side; from opposite a point 1.1 metres north of the common boundary of Nos. 1/2 Brookfield Terrace, Pyrles Lane for a distance of 5.5 metres in a southerly direction.

Rochford Avenue, Waltham Abbey

Southwest side; from a point 1.5 metres southeast of the north-western flank wall No. 71 for a distance of 5.5 metres in a south-easterly direction.

Roding View, Buckhurst Hill

Southeast side; from a point 4.6 metres southwest of the common boundary of Nos. 31/33 for a distance of 5.5 metres in a south-westerly direction.

Skarnings Court, Waltham Abbey

North side; from a point 2.3 metres east of the western flank wall of No. 1 for a distance of 5.5 metres in an easterly direction.

Springfield, Epping

East side; from the northern flank wall of No. 31 for a distance of 5.5 metres in a southerly direction.

St Peter's Avenue, Ongar

- (i) North side; from the western flank wall of Nos. 20/22 for a distance of 5.5 metres in an easterly direction
- (ii) West side; from a point 0.5 metres south of the common boundary of Nos. 4/6 for a distance of 5.5 metres in a southerly direction.

Takeley Close, Waltham Abbey

Northwest side; from a point 0.9 metres northeast of the common boundary of Nos. 13/14 for a distance of 5.5 metres in a north-easterly direction.

The Street, High Ongar

East side; from a point opposite the southern flank wall of the property known as 'Rowlands' for a distance of 5.5 metres in a northerly direction.

Theydon Grove, Epping

Northwest side; from opposite a point 3 metres west of the common boundary of Nos. 94/96 for a distance of 5.5 metres in a north-easterly direction.

Thriffs Mead, Theydon Bois

- (i) Northeast side; from the common boundary of Nos. 34/35 for a distance of 5.5 metres in a south-easterly direction
- (ii) Northeast side; from a point 4.4 metres southeast of the north-western boundary of No. 38 for a distance of 5.5 metres in a north-westerly direction.

Torrington Drive, Loughton

Northwest side; from a point 6.6 metres southwest of the south-western boundary of Nos. 75/79 for a distance of 5.5 metres in a south-westerly direction.

Woodford Court, Waltham Abbey

West side; from a point 1.8 metres south of the northern flank wall of No. 1 for a distance of 5.5 metres in a southerly direction
