


**THE ESSEX COUNTY COUNCIL (EPPING FOREST DISTRICT)
(PERMITTED PARKING AREA AND SPECIAL PARKING AREA)
(AMENDMENT NO.4) ORDER 2009**

Essex County Council (hereinafter referred to as 'the Council') in exercise of its powers under sections 1-4, 32, 35, 45, 46, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ('the Act'), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as The Essex County Council (Epping Forest District) (Permitted Parking Area And Special Parking Area) (Amendment No.4) Order 2009 and may be construed as one with the Essex County Council (Epping Forest District) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008 (hereinafter referred to as 'the 2008 Order'), and additional restrictions detailed within this Order are subject to the same provisions applying to the relevant Schedules of the 2008 Order.
2. The prohibitions and restrictions detailed in Schedules 1 to 9 to this Order are hereby introduced into the appropriate Schedules to the 2008 Order.
3. The prohibitions and restrictions detailed in Schedules 10 to 19 to this Order are hereby revoked from the appropriate Schedules to the 2008 Order.
4. This Order shall come into operation on 24 August 2009.

Schedule No 1

Additions to Schedule 1 of the 2008 Order - No Waiting At Any Time

Baldocks Road, Theydon Bois

The north-east side from a point 8 metres south-east of the common boundary of Nos. 2/4 Baldocks Road for a distance of 26 metres in a south-easterly direction
