Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Epsom & Ewell) (Prohibition of Stopping Outside Schools) (No.1) Order 2005 (Amendment No.1) Order 2005" and shall come into operation on 10 October 2005

Interpretation

- 2 (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Epsom & Ewell)(Prohibition of Stopping Outside Schools)(No.1) Order 2005_____
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment_____
- (3) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order_____

Amendment of The Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though:-
