THE EPSOM AND EWELL (PAY AND DISPLAY PARKING PLACES)

(FIRST AMENDMENT) ORDER 1987

Made: 15th March 1988

Coming into Operation 9th April 1988

The Council of the Borough of Epsom and Ewell in exercise of their powers under Section 35(1) of and Paragraph 27(1) of Schedule 9 to the Road Traffic Regulation Act 1984 and all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Paragraph 20 (1) of Schedule 9 to the Road Traffic Regulation Act 1984 and with the consent of the Surrey County Council, hereby make the following order:

Citation and Commencement

1. (1) This Order may be cited as the Epsom and Ewell (Pay and Display Parking Places) (First Amendment) Order 1987
- (2) This Order shall come into operation on the 9th of April 1988.

Interpretation

2. (1) In this Order "the Order of 1987" means the Epsom and Ewell (Pay and Display Parking Places) Order 1987.
- (2) The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Amendment of the order of 1987


3. Without prejudice to the validity of anything done or any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 1987 shall be amended as follows:-


(i) the Order of 1987 shall take effect as though the plan attached to this Order were included in the Order of 1987 and the Schedule hereto were added to Schedule II to the Order of 1987 and the terms and conditions of the Order of 1987 shall apply to the parking place shown on the said plan;


(ii) the Order of 1987 shall have effect as though the plan attached to that Order relating to Car Park number 10, Swimming Centre were deleted; and


(iii) the words "Car Park No. 10 Swimming Centre" in Article 21(2) of the Order of 1987 and the provisions regarding Car Park No. 10 Swimming Centre in Schedule II to the Order of 1987 are hereby repealed.
